IN MEMORIAM

<u>Chris O'Farrell</u> passed away on November 20, 2010. Both of his parents are retired members of FBA and our thoughts are with them in their loss. (Words from his mother.)

Chris was the true definition of what FBA hopes to create. He made All State (as well as All County) every year he was eligible. He made the all state concert band, orchestra, and lead in the jazz band. He attended music camps run by FSU, UF, and Jamey Aebersold. He went to UM on full scholarship and studied with the greatest trumpet teachers and directors (Gary Green, Whit Sidener, Gil Johnson, to name a few). In 2000 he was selected for the Disney Collegiate Band and performed 6 shows a day at Disney World, while living at the "Snow White Village" (a trailer park). He traveled to Morocco with Paul Anka; performed "Fame" for 6 weeks in South Korea; was in the house band from Washington to Alaska on many cruises; played with the Ojays on cruises to Puerto Rico and other Caribbean islands; played lead with the Woody Herman Band on the West Coast of Florida tour; just to name a few of his accomplishments. In 2010 he was awarded the Downbeat Magazine's Student Performer Award for Trumpet Playing on a submission from UM. He was the assistant conductor of the salsa band at UM as well as its lead player. He wrote marching band arrangements for Everglades and McArthur High Schools. He wrote drill for Everglades for 8 years; helped write for Hollywood Hills for 7 years; and helped with marching techniques at several other schools. His orchestral arrangement of Queen's "Bicycle" is legendary, as is his original salsa jazz piece of "Los Gringos". I believe the FBA should be proud to have helped produce such a fine musician. Even though his years on this earth were cut way too short, his accomplishments were more than many.

FBA CONSTITUTION ARTICLE VI - ELECTION OF OFFICERS

Section 2. DISTRICT OFFICERS

District Chairpersons/Treasurers and District Secretaries shall be nominated by the District members at a meeting prior to the November/December meeting of the Executive Board. District Officers will be elected by secret ballot at the January/February District meeting. Odd-numbered Districts shall hold elections in even-numbered years. Even-numbered Districts shall hold elections in odd-numbered years. **Qualifications for nomination to a District Officer position: FBA members in good standing must** have (1) completed 5 full years of band instruction in Florida; (2) have had regular attendance at FBA District and State meetings during those same years; (3) have had active participation in FBA sponsored activities, including clinics, conferences and Music Performance Assessments during those same years; and (4) be willing to accept the responsibility of the office, and follow the guidelines set forth by the FBA Executive Committee.

PASSED BY THE MEMBERSHIP

1. Remove "routine must be at least 1:30 (one and one half) consecutive minutes of the 2 to 3 minute period" located in Handbook p. 23—III-H.4.e (Saber), 5.e (Rifle), 6.e (Flag) and revised version (p. 2 for Flag and Rifle, p. 3 for Sabre). Replace with "Performers must keep equipment in hand at all times except during release moves." **Rationale**—Solo choreography should focus (during the entire routine) on the chosen equipment.

PASSED BY THE MEMBERSHIP

2. Delete page 13 of the Adjudication Manual. **Rationale**—This page is connected to the previous adjudication sheets which were revised several years ago, making it obsolete.

3. Approve the revised and clarified auxiliary section of the FBA Handbook, to replace the current Auxiliary section starting on page 22. **Rationale**—This proposed revision provides consistency among performance areas and clarity overall.
