JUNIOR HIGH / MIDDLE SCHOOL REPRESENTATIVE REPORT - Linda Mann

Report to the Executive Board:

7 & 8 grade All State Honor Band

- There were 129 students from 129 schools in the honor band this year.
- Two students opted to go into a different All State ensemble. They were replaced prior to January.
- Only 3 forms not considered this year due to being filled out incorrectly.
- A number of schools sent parent checks with their forms. These had to be sent back and new checks re-issued before the deadline.
- Four schools missed the postmark deadline.
- Nine schools did not have a student placed in the band. They will receive first

consideration next year providing they turn in a form correctly and on time.

Concerns/Recommendations

Directors need to send more names on the forms and include color instruments. There was a large amount of forms with only one name. This limits possibilities for a school to have a student in the ensemble.

Directors are not precise when filling out the forms. They are using incorrect or incomplete mailing addresses for their schools and no email. This becomes a problem when sending the music and corresponding with the directors prior to the event.

All State Participant Contracts were not turned in to district chairs. Honor band seemed to be "forgotten". I would like to recommend that we require a copy of the participant contract be sent with the forms and checks to avoid this problem.

1. Audition Process Update

- a. Audition requirements were sent to the district chairman and posted to the FBA website on May 14, 2009. No mistakes have been found at this time.
- b. The timpani exercises come from the same book we used last year. The exercise is not on-line this year.

2. All State Timeline – Tentative

- a. The current timeline for auditions and results is as follows.
- Summer Convention- All State handbook is presented to District Chairpersons introducing new computer system.
- 1st District Meeting- Forms and info (mock audition and CD recorder demonstration?) presented to membership.
- Prior to auditions- Forms and fees are due to District Chairperson.
- September 1, 2009- Directors MUST be members of FBA/FMEA by this date.
- September 10-19 All-State auditions are held in respective districts.
- September 24 ALL All-State materials due to individual committee chairpersons.
- September 26 All-State Committee meeting.

- September 28 Tapes distributed to audition listeners.
- Early November List is sent to District Chairman for distribution. One day later list is posted to FBA website.
- Prior to Thanksgiving week- Music is sent to students.

3. Proposal to the Executive Board

Change the FBA Small Schools Honor Band to an Honor Band that is representative of all FMEA/FBA member schools.

- 1. Small School's students will be selected first
- 2. Only one student per band program
- 3. Any school that has a student make the audition band is not eligible to have students participate in the honor band.
 - 4. Instrumentation needs will supersede any of the above guidelines
 - 5. Band membership shall not exceed 130 members

Rational:

- 1. As school systems change more and more requirements are put on schools that follow trends other than school size. Many of the larger schools are in situations that create the same limitations that small schools face.
- 2. More band directors will have the opportunity to use "line of duty" leave vs. "professional" leave because more schools are represented. This gives an even stronger rational to attend the FMEA convention.
- 3. Currently we are having to use multiple students from the same school to fill the honor band. We are also using students from schools that are represented in the audition bands. While we would love to allow every student to have the "All-State Experience" the committee feels it is advantageous to include as many schools as possible.

The following report is from the Professional Resources Committee (PRC) meeting on Wednesday, January 7, 2009 at the Tampa Convention Center during the Florida Music educators In-Service Conference.

- Discussion Items
 - Why FBA directors do/do not attend Summer Clinic?
 - Brian Wuttke volunteered to design and implement a survey to determine why members of FBA do/do not attend Summer Clinic.
 - The need to *hear* guest conductors at FMEA.
 - The Committee recommends that All-State guest conductors at FMEA wear a wireless microphone so that observers can hear the comments that these conductors make to the students. Hearing these comments will provide a valuable learning opportunity for FBA members.
 - Provide FBA members an opportunity to study the rehearsals of the All-State ensembles and their conductors.
 - The Committee recommends that the All-State rehearsals be videotaped, edited, and uploaded onto the FBA website so that FBA members can then download these rehearsals for study purposes.
 - o At FMEA, invite master conductors to use an already-performing middle school band and high school band in a clinic format.
 - At least one middle school band and one high school band are generally "invited" to perform at the FMEA conference. FBA members would benefit from a session of having master conductors work with these ensembles to demonstrate specific musical and pedagogical skills.
 - The Committee recommends that a panel be formed and held at the next (a) summer and (b) FMEA conventions to discuss the opposing views of the marching band controversy.
 - The Committee feels that the marching band issue needs considerable discussion in an *open* format and over time, at more than one FBA conference.
 - Suggestions for a Summer or FMEA conferences:
 - "Common Sense Approach to the Small High School Marching Band" (suggested clinician – Wansley).
 - "How To Find Money for your Band Program that is Not There."
 - Many small county budgets contain money that band directors could access but do not know about, nor do these directors know how to access these funds.
 - "How to Finance Private Study."
 - A panel of middle and high school directors who have experience on this topic.
 - o Suggestion:
 - The Committee suggests that FBA provide the audition recordings of the top X number of players that make the All-State bands for the directors to use as models for their students.

FBA MENTORING COMMITTEE REPORT Travis A. Henry, Chairperson MAY BOARD MEETING – MAY 15, 2009

There are many new challenges now facing Florida teachers, especially in the area of music education. More and more, we are hearing about program being either reduced or eliminated as a result of our state's current budget shortfalls. How does this affect our band directors? Well, it makes the need for mentoring even more important. As a result, the committee will continue to move towards providing more resources for teachers by which they can improve networking with colleagues, getting information to as many people in the most cost effective way.

We will continue to pursue efforts in achieving our established goals:

- Providing podcasting and webcasting as a way to get information to struggling teachers
- Strengthening our mentoring efforts at the district level
- Educating our membership in the need for asking for help (tearing down the barriers)
- Assisting district chairs with resources that they can share with members

We would also like to begin work on a document that would supplement the FBA handbook in providing information by which a band director can operate a successful program. The approach would be something like "Band Directing for Dummies", but, of course, it would not be called that! As much as our colleges and universities prepare new teachers, and for as much as we assume that new teachers "should know better", the fact remains that the new teachers is more naïve than ever about the "ins and outs" of effective teaching, administration, organization and management of time. For this effort, we will need our members to share ideas, secrets, and any other information, so that we can compile a worthwhile document. The goal is to accomplish this by August 2010 for the 2010-11 school year. We could post it on the FBA web site as a download or e-mail it to our entire membership (whichever is easier). That way, everyone has access to the information.

In all, mentoring needs to continue to be part of the solution in providing quality service to our membership. Teachers need assistance, no matter what stage of our careers we may find ourselves. I had a music supervisor make a comment to me, as she observed me talking to some judges during a break. She wished that more directors could hear the conversation that we were having, as we talked about struggles we shared as directors, and how we solved them. Let our organization be about the business of learning from each other, strengthening each other, and making music education better for the sake of Florida's children and our music students!!

NEW BUSINESS

District 1

Motion: McLeod, Adams To add a line to the FBA Jazz Band MPA adjudication sheet that would indicate how often the ensemble meets each week.

Rational: An adjudicator could offer better feedback if he/she knew how often an ensemble rehearses. An ensemble that rehearses 7 ½ hours per week would need different comments than an ensemble that only rehearses 2 hours per week.

#8 MOTION DEFEATED BY THE BOARD

District 5 (to Committee)

MOTION: A motion sent to committee for further discussion or action must be defeated or returned to the board for a vote no later than two meeting following its initial presentation to the board. (e.g., a motion presented in July would be returned to the board, either defeated in committee or for a vote by the board, no later than following May's Board meeting.) In addition, each committee shall submit a list of all motions in their committee still awaiting action prior to each Executive Board Meeting. This list shall be published in the minutes following FBA Board Meetings.

Rationale: A motions sent to a committee for enhanced discussion or to receive greater attention from more informed members is hard to track once it goes to committee. While committees give reports on motions they have addressed during any given period, motions that remain on their docket are not addressed. This motion encourages timely action by committees

and would allow the membership and districts to easily track the progress of motions that have been referred to committees from the Executive Board.

MOTION: Crocco/Ledbetter MOTION PASSED

#9 MOTION DECLARED OUT OF ORDER

District 7

MOTION I: To allow Jazz Bands to perform at Jazz MPA for a rating as long as the Bass part is being covered by another instrument - D. Dubay and C. Sleeper.

RATIONAL: A Bass part can be covered by a keyboard or a tuba and still keep the integrity of the music. Not all Band programs are able to accommodate a Bassist for MPA.

#10 MOTION DEFEATED BY THE BOARD

MOTION II: Propose that the Solo and Ensemble committee consider allowing Bass Clarinet students to perform from the Bb Clarinet ensemble list - R. Morris and K. Lewis RATIONAL: There are currently no trio/quartet ensemble music on the list for bass clarinet, and excludes them from being included. Also, this could apply to Tenor sax and Bari sax trios. If this is being allowed, then the handbook should be changed to reflect this.

#11 MOTION DEFEATED BY THE BOARD District 9

Motion #1: A change to the FBA rule, which permits only bands who earn a rating of straight superior to be the recipient of a superior plaque at the State MPA level.

Rationale: It is important to principals and school board members, especially in today's budget crisis's, to have physical evidence of the success of music programs in their school. Each year FSMA publishes hard copies of each school music report, however these are not seen until after the school year is completed. The development of a new plaque would allow us to keep the prestige of the Otto J. Kraushaar award.

(Greg Urban – Motion, Dan Wood – Second)

#12 MOTION DECLARED OUT OF ORDER

Motion #2: A change to the FBA classification system which would be better suited to provide fair and equal performance opportunities to schools of all sizes. Article III-A-3 of the FBA Handbook currently requires each school to classify according to the overall size of their school enrollment. Article III-A-9 of the FBA Handbook also permits schools to reclassify if justified under certain circumstances, which are to be voted on by the district and if passed, move onto the state board for approval.

Rationale: Many larger schools throughout the state are showing lower enrollment sizes in band classrooms, which make it difficult to prepare required classification music. While the alternative of reclassification is available, this practice is supposed to be limited. A change to a system that would allow music selection to be the basis of classification, would allow directors the discretion of choosing music based on the instrumentation of their individual program. (Chris Benoit – Motion, Greg Urban – Second)

#13 MOTIONED DECLARED OUT OF ORDER

Motion #3: A return to combining State Concert MPA and State Solo & Ensemble MPA to the same time and site.

Rationale: Joining these two major events together would allow for more opportunities for students and directors to view other programs from around the state, which only

promotes the learning experience. Performing at State MPA's is a privilege that deserves an audience of listeners who understand how much work goes into a performance. With tightening budgets, this would also allow savings of travel costs for programs.

#14 MOTION DEFEATED BY THE BOARD

District 10

Motion: Eggen/Schwindt Give bass trombone players permission to play solos from the Solo and Ensemble Tuba list.

Rationale:

It is common for college and professional bass trombone players to perform tuba solos, such as the Beversdorff "Sonata for Tuba" and the Vaughan-Williams "Concerto for Bass Tuba." Currently, there are not many solos available to bass trombonists; after studying the list, we can count approximately 12, with all between the grade 4-6 range.

In the same way that piccolos may choose suitable solos from the flute list, bass trombonists should have the opportunity to perform music that is suitable for them. The Florida Bandmasters Association is treating the bass trombone as a separate instrument, as demonstrated by the totally separate audition process required for All-State Concert Bands and Jazz Band. The Executive Board and the S & E Committee should do the same by giving these student musicians a greater selection of music to choose from.

#15 MOTION PASSED BY THE BOARD

Motion: Stewart/Molineaux- Passed

Proposal:

On behalf of the Band Directors of Osceola County we would respectfully request to become our own FBA district beginning with the 2010-2011 academic school year.

Rationale:

With the current economic status it is very difficult for many of the bands in Osceola County to travel to Brevard for FBA District Marching MPA, and Solo and Ensemble MPAs. Due to this high transportation expense, the participation level for many of our schools has declined, but if we were able to become our own district participation in events will increase, especially solo and Ensemble.

In addition, the School District has stated that all high school band programs will be involved in future FBA events and is currently talking to the middle school programs regarding their participation in the future.

Osceola County currently has a total of 19 existing band programs, and with the addition of Harmony Community School which will opened in 2008 and West Side k-8 opening in the fall on 2009, we will have 21 band programs.

Currently, Osceola County has been host to a FBA District Concert MPA day for the past several years and has experience hosting Marching Events, as we have been having a county wide Marching Band Extravaganza for the past 20 years. In addition, the Band directors have already established a chairman and secretary role to organize current county events.

1. GENERAL INFORMATION ...

- c. Students participate in the Solo and Ensemble Music Performance Assessment in two categories: Senior High/High School, and Junior High/Middle School.
- 1) Senior High Grades 10, 11, 12, or

High School or Junior/Senior High - Grades 9, 10, 11, 12:

Must play grade III or higher music from the FBA Music List ...

2) **Junior High/Middle School -** Grades 6, 7, 8, 9:

May play any grade music on the FBA List."

PROPOSED ADDITION:

"Exceptional Student Performer (ESP)

- 1. "Exceptional Student Performer" identifies a student who needs special exceptions to the Handbook Rules. ESP is not an event.
- 2. In any event, regular rules regarding music grade level may be altered for entrants who have been identified as physically or mentally challenged by the school system or a medical doctor.
- 3. ESP may be a temporary or a permanent identification. Some students may have temporary problems which would identify them as ESP. They would return to the Handbook Rules when the problems cease.
- 4. When a director is seeking ESP status for a student, she/he must complete the ESP Official Application. This must be submitted to the district chairman with the school entry form. Based on the nature of the student's special capabilities, instructions and information on modifications allowed to the entrant will be provided for the judges.
- 5. Neither the words "Exceptional Student Performer" nor the initials "ESP" are to appear on the rating sheet.

Note: Modifications and accommodations apply only to the District level. This does not alter the qualifications for State Solo and Ensemble Music Performance Assessment."

MPA ONLINE will need to be adjusted to allow this entry for Senior High, High School, and Jr/Sr High."

Motion: Provide FBA members secure online access to the voting records of all State Executive Board members on motions presented to the board.

Rationale: To provide a clear and transparent system of accountability to all members of the Florida Bandmasters Association and to ensure that the interests of the individual districts are being represented accurately by their elected representative. This motion will serve to empower District Chairpersons to vote the conscience of their district without concern of pressure from outside influence. This is similar to the United States Legislative Branch, where the voting records of all Senators and Congressmen are recorded and a matter of public record. #18 MOTION DECLARED OUT OF ORDER

District 20

Band Directors should be provided with the judging criteria (rubric) for All State auditions. (Bobby Keating)

Rational - We have a rubric for all other adjudications, very helpful when we prepare our bands for MPAs. A grading policy would help directors to prepare students for the audition. Students should have the same advantage for All State auditions.

#19 MOTION DECLARED OUT OF ORDER

Proposal: Leibinger/Goff

Amend handbook Section III - C.4.h. to read:

Bands that obtain permission to perform in the District Music Performance Assessment outside of their own district shall pay a per-unit assessment (marching, concert and/or jazz bands) based on the amount of time their participation will extend the hosting district MPA. That rate will be determined by the number of judges needed x pro-rated hourly rate x ½ for marching band (max. 15 minute performance), ½ for jazz band and JH/MS, C, CC, B, BB concert band (maximum 30 minutes performance), ¾ for A, AA concert bands (maximum 40 minute performance.)

Bands that perform out of district will still be responsible for their home district's per-student assessment based on their concert or marching entries, whichever is higher.

Bands that obtain permission to perform in the District Solo/Ensemble Music Performance Assessment outside of their own district shall pay a per-student or per-unit assessment based on the rate of assessment of the hosting district. Rationale:

Due to scheduling conflicts, more and more bands are being granted to perform out of district. The current Handbook reading of Section III-C.4.h leaves the assessment required up to the decision of both District Chairpersons involved. It also leaves open the possibility of a band going out of district having to pay double assessment OR if the Chairs are not in communication, to pay NO assessment. The wording of this proposal will leave the larger assessment (for marching or concert) in the home district, where the majority of the funds are needed. It also makes the financial responsibility for a band performing out of district reasonable and clear.
