participating in any MPA based on FSMA policy. Students will benefit from the educational opportunities provided by Concert MPA. (B. Kelly/Townsend PASSED)

## #3B BERRY/DELL TO SEND TO THE MPA COMMITTEE - PASSED

#### **District 4**

# 1. Form a Suggested MPA Literature list for poor instrumentation with guidelines for rescoring techniques by Lori Pirzer 2nd Dorsey - motion passed

**Proposal**: I would like to propose that a committee be formed to create a Suggested MPA Literature list, from our current list, for high school bands that have poor instrumentation. In addition to the list the committee should also suggest some allowable rescoring techniques to help cover parts. The committee should be made up of band directors that have had success working with small bands with challenging instrumentation.

**Rationale:** At the high school level it is difficult to be successful at MPA when you are a small ensemble with poor instrumentation. There are many directors that have made this work and are successful because of their choices of literature for their band and some creative rescoring to cover parts. Having experienced, successful directors create a suggested list would be very helpful to other directors, especially new directors, that are in this situation.

## #4 KAMINSKY/EFSTATHIOU TO SEND TO THE SMALL SCHOOLS COMMITTEE AND THE CLINICS COMMITTEE - PASSED

2. A rubric for each rating be found on the Concert MPA adjudicator sheet by Lori Pirzer 2nd Cobbmotion passed

**Proposal:** I would like to propose that a rubric for each rating be created and placed on the back of the Concert MPA adjudicator sheet for both district and state MPA, so that it could be used for all MPA's in 2012. **Rationale:** Rubrics built better understanding for why a certain rating is given. This would allow directors and their students to understand what they need to improve within a given rating. A rubric exists for the marching MPA sheets but not for Concert MPA sheets.

## #5 KAMINSKY/EFSTATHIOU TO SEND TO THE MPA COMMITTEE - PASSED

#### District 8

**Motion: To stop or postpone the deletion of titles from the concert band music list**. (Antmann/Eaddy) Passed **Rationale**: With all due respect to the committee that met to alter the concert music list- 1. There needs to be more transparent procedure for such a significant task, and more input should be solicited from the general membership. Music is subjective, and there are numerous unique situations throughout the state. While members of the committee may not think certain pieces are not of high quality to be included, other directions may have good reasons that they should be. 2. Some pieces are being removed that have just been added recently. Is there a reason that a piece was good enough to be added a year or two ago, but is suddenly not good enough to remain on the list? 3. With budgets shrinking and funding for music hard to find, it is not a good time to remove music that many directors may have in their libraries. Some directors have spent significant money on music because it is on the FBA list. 4. The fact that a piece of music is out of print should not be grounds for removal. Music goes out of print for a variety of reasons. 5. There should be specific criteria given for the removal addition of music to our list. 6. Before any music is removed, a procedure should be added to the FBA handbook, and should be voted on by the membership. This is necessary because of the importance of music performance assessments, especially with performance pay coming, and with the expense involved (purchasing music).

### **#6 MOTION FAILED**

# Motion: A procedure for the addition and deletion of music on our music lists should be added to the FBA handbook. (Antmann/Sullivan) Passed

**Rationale:** With the increased emphasis on assessment and accountability, it is important that all parts of the MPA process are clearly outlined in our handbook. Even if it is something short, there needs to be some mention. Right now the committees are mentioned, but the process is not. The music list is the content for our assessments, and should be addressed.

## **#7 JENNINGS/DELL TO SEND TO THE MUSIC COMMITTEE - PASSED**

#### District 12

Motion: R. Combs/ D. Fultz - Students who are currently enrolled in a piano class in a middle school or high school music program that are taught by an active, dues paying member of the FBA be allowed to participate in the District's Solo and Ensemble Music Performance Assessment.

**RATIONALE**: The philosophy of the FBA believes that instrumental music education is an essential part of the school curriculum and that it must always be flexible to change. It further believes that it is important to stay ahead of trends and to always protect the best interests of our music students. Therefore students who are studying piano in middle school or high school should be afforded an equal opportunity to participate in the District S&E MPA. However, the classroom piano teacher who is directly responsible for those students must be a bonafide member of the FBA and be thoroughly knowledgeable of the structure and rules of the Association. Motion passed.

## #8 BERRY/EFSTANTHIOU TO SEND TO THE MPA COMMITTEE - PASSED

#### **District 16**

1. Motion to allow elementary concert bands to participate at MPA's for "Comments Only".

**Rationale**: Students will receive feedback from official adjudicators and will know what to expect when they move on to a secondary school. Young musicians understand the maturity level they must achieve when performing at MPA. FBA's mission statement is to support all band programs in our state. They should support all band no matter what grade level the students are in. Motion by Oliver Diaz, 2nd George Ortiz-passed

## #3C BERRY/DELL TO SEND TO THE MPA COMMITTEE - PASSED

2. Motion to change the language in the FBA handbook regarding title changes for Concert Band Assessments. I would like it to read, "Title changes for selections to be performed at District and State Performance Assessments must be made with the Music Performance Assessment officer at least at the time of registering at the Music Performance Assessment and prior to performing."

**Rationale:** We already do this for Jazz Band Music Performance Assessments with no dilemma. The Music Performance Officer Assessment Officer will have at least one hour to verify the grade of music and classification of the ensemble to verify that is covers all FBA requirements. This will prevent the many Comments Only and Disqualification ratings for our students. Motion by Jennifer Jimenez, 2nd by Daniel Ibarra-Scurr-passed

### **#9 MOTION FAILED**

#### 3. Motion to allow MS students to participate in a MS All-State Jazz Ensemble

**Rationale**: We already have a MS Concert Band All-State ensemble; Why should we deny the opportunity for those who enjoy Jazz Ensemble the opportunity to perform with such an elite group of musicians. FBA clearly states in its philosophy statement that, "FBA must always be flexible to change, to stay ahead of trends and to always protect the best interests of our students and music." Let us provide this opportunity to those MS students who excel in Jazz as well. Motion by Erich Rivero, 2nd by George Ortiz-passed

## #10 DELL/JENNINGS TO SEND TO THE ALL STATE COMMITTEE TO DEVELOP GUIDELINES AND DETAILS FOR IMPLEMENTATION - PASSED

#### District 19

Motion: Fielder/Langford - The Executive Board will direct the Finance Committee to allocate \$3000 for the purpose of converting the cassette recordings of state superior bands to CD. The \$3000 would be used at the discretion of the custodian of these recordings, currently P.L. Malcolm

**Rationale** - These tapes are deteriorating from frequent copying, many are stretching and we are in danger of losing these resources. There are approximately 250 tapes and the average cost to covert a tape to CD is below \$10. In speaking with Mr. Malcolm about this project, hiring a professional firm to handle this task is our best bet for insuring the long term viability and quality of the recordings. \$3000 would cover the cost associated with conversion plus any shipping costs.

### STATE S&E MPA

After discussion, it was the consensus of the Board to continue with 3 sites, scheduling 2 days

for a North site, 3 days for a Central site, and 2 days for a South site.

## STATE BAND MPA

After discussion, it was the consensus of the Board to NOT have the clinic session at State for another year, to stay with 4 sites if possible, to secure quality facilities as host for the State Band MPA, and to start the schedule later in the day (after noon).

- d. Soloists must play at least a Grade V solo at District and State. To be eligible for State, the student must make a Superior rating at the District Music Performance Assessment, and must play the same grade level of music or higher as was done at District. The Superior with Distinction medal will be given to those students who play their solo **and/or ensemble** from memory.

Rationale - Students who perform ensembles from memory at State Solo and Ensemble MPA and are awarded a Superior rating should receive the same level of commendation as soloists.

## **Report of the Florida School Music Association Board of Directors Meeting, February 28, 2011, Tampa, Florida**

The following are highlights of the meeting - minutes are posted on the FSMA website.

- I. Past-President David Lewis introduced Dr. Kathy Sanz as the new Executive Director of FSMA.
- II. Board accepted the FBA, FOA and FVA component audit reports. Discussion of minimum required balance in District bank accounts led the board to approve a motion to allow districts to leave up to \$1500.00 in their summer account to avoid bank charges.
- III. Kathy Sanz provided a 2nd reading to the bylaws change motion passed in October 2010: To substitute "Advisory Members" for "Ex Officio Members" and to indicate the Advisory Members are non-voting members of the Board. (original motion: James Perry/Jeanne Reynolds) - Approved (2 Nays)
- IV. Discussion of who the "officers" of FSMA are resulted in the following bylaws change motion: The officers of the Association shall consist of 2 positions (President, an immediate Past President, and/or President-elect). In addition, a rotating (FBA/FOA/FVA) executive director will serve as advisor. (Ruth Heckman/Jennifer Rhodes) - Approved (1<sup>st</sup> reading)

- V. David Lewis shared that Polk County will be applying to FDOE for and RFP Grant to develop fine arts assessments as mandated by new legislation. The FSMA Board voted to provide a letter of support of this application.
- VI. Tim Cool (Cocoa Beach) was elected FSMA President (replacing Kathy Sanz).
- VII. Informational Items:
  - a. Kathy Sanz informed the board that a formal and thorough review of FSMA policies will be conducted. A member of each component will be asked to serve on this review committee chaired by Ken Williams.
  - b. Jeanne Reynolds discussed the House and Senate bills that are facing the state. Communication from FSMA will be going out pertaining to the various issues.
  - c. Beth Cummings stated that the NGSSS were approved in December 2010. Course descriptions are being developed; Phrase I includes elementary (chorus, band, orchestra), middle and high school (band and chorus). Public review will be coming soon.
  - d. Kathy Sanz noted that this will be Duane Hendon's last meeting due to his retirement and the Board thanked Duane for his service.
