Here is an email I received from Barbara Johnson and her students from Amman, JORDAN, shortly after the January convention. Music touches lives all over the world. This is the first State Bulletin since that time that I could share this with you. They were our special guests at the 2003 FMEA State Music Convention.

Many times we as music educators take for granted our rich heritage of music education and music making here in Florida. It has been my privilege for the last 15 years to share some of that heritage with the Kingdom of Jordan. In the midst of state-of-the-art computer technology and advanced medical science, music is still in an embryonic stage in Jordan. The Amman Baptist School boasts the <u>only</u> band program for Jordanians in a country of 5 million people. I chose four of my outstanding students (and a former student as chaperone) to accompany me to FMEA conference this year. Here are some of their impressions and comments:

"I was one of the lucky people who was chosen to attend the FMEA convention in Tampa. It was a very good experience for all of us...we were invited as special guests and we were recognized by many people. We were a bit embarrassed but proud at the same time. I think this convention gave us a very good idea of the level music can reach and will help us a lot to improve music as a whole in Jordan." Yazan Madanat, 10th grader

"We attended many conferences, concerts, and performances...We now understand that music isn't just for fun, but music can make a difference in our lives. Attending the music conference was a new experience for us, and a great one! We are excited to return to Jordan and improve our band with the new ideas we learned. In addition to the conference, our group visited 6 schools in Polk County and participated in rehearsals, observed classes and interacted with music students at each school. "We went mainly to Florida to attend the FMEA conference to learn more about music to help others in Jordan. We went to share with schools about our country and to see how we are different and how we are the same...we were amazed at the amount of time the groups practice throughout the week... we realized our rehearsals are not enough. We are quite serious now about what we as students can do to improve music in Jordan and help music take a bigger place in Jordanian's lives." Ramzi Abbassi 9th grader.

Our trip was rounded out by a day at the Cape and of course a stay at Disney. Each of the students and I would like to express our sincere thanks to Duane Hendon, Rod Roadman, Carolyn Minear, Phil Wharton and Frank Howes for making our visit official and a tremendous success. It was an experience of a lifetime for me and for my students, one that will definitely help mold the future of music education in the country of Jordan. Thank you FBA and thank you FMEA! Adjudication Committee Report

Board Meeting – May 2003 Orlando, Florida

Committee Members: Rodney Dasinzer, Wayne Gallops, James Matthews, Mark Nelson, Bill Reinecke, Bentley Shellabamer

The Adjudication Committee met in Orlando on May 10, 2003. The following recommendations come to the Board from the committee:

I. Recommendation:

The honorarium for State Concert Band MPA Adjudicators/Commentators should be increased to \$240.00 per day. **PASSED**

II. Recommendation:

The Marching Band MPA ratings chart, currently on page 14 of the Adjudication Manual should be replaced with a new chart which shows all possible permutations of ratings (see attachment) **PASSED**

III. Recommendation:

The following corrections and/or additions should be made to the current Adjudication manual:

- a) Page 9, section E, 2nd paragraph replace statement concerning use of the (+'s) and (-'s) with: "Officials may include a (+) or (-) by the subdivisions, which will mean they are noticeably good or noticeably needing improvement as related to the letter grade assigned. The absence of any marks indicates a performance that is consistent with the letter grade assigned."
- b) Page 5, section IIIC., Solo/Ensemble add the following parenthetical statement after Solo/Ensemble 24 performances *(each category)*
- c) Page 3, Section D, #1: delete "or teacher of Twirling/Auxiliary groups" from #1. Sentence should read: "Have a minimum of 7 years experience as a Band Director at either a Middle School, Junior High, High School, College, or as a conductor of a recognized instrumental music organization."
- c) Page 3, Section E, Heading Change heading to read: "Requirements for Auxiliary/Twirling Adjudicators (Marching Band and Solo and Ensemble)"
- d) Page 3, Section E, #1: Change sentence to read: "Have a minimum of 7 years experience as a Band Directors at either a Middle School, Junior High, High School, or College, or as a teacher of Auxiliary/Twirling groups

ALL THE ABOVE PASSED

IV. Recommendation:

To become certified, Auxiliary/Twirling Adjudicators must attend the Marching Band Certification Seminar, plus one Auxiliary Clinic at Summer Convention every three years. **PASSED**

V. Recommendation:

To become certified, Out-of-State adjudicators must attend an Adjudication Seminar appropriate for their categories, or complete the Interactive CD-Rom for Adjudicator Certification. **PASSED**

VI. Recommendation:

To become certified, College/University adjudicators must attend an Adjudication Seminar appropriate for their categories, or complete the Interactive CD-Rom for Adjudicator Certification. **PASSED**

VII. Recommendation:

District Chairs shall instruct all Solo and Ensemble adjudicators at the beginning of each S&E MPA that they should not be alone in a room with a student. This caution should also be added to the District Chairs Handbook. **PASSED**

VIII. Recommendation:

Persons who are applying to become adjudicators who are not school band directors must include a professional resume' with their application materials. **PASSED**

IX. Recommendation:

The committee reviewed the credentials of the following applicants, and recommends that they be allowed to begin Adjudication Internships in the designated categories:

All-State Selections Committee Report FBA Executive Board, May 16th, 2003

I. Update

The Audition requirements were posted to the web site on May 1st as planned. As of Monday, May 12th no problems have been noticed and reported. Please continue to monitor the web site for changes to the requirements as they become necessary.

II. New guidelines for tryouts and bands

In an effort to clarify and streamline we have made some changes...

- All Piccolo students MUST also audition on flute. Their flute audition will determine
 membership in the band and the piccolo double will be determined by the piccolo audition. The
 Piccolo audition will contain the chromatic scale and exercise no other scales and no sightreading.
- All English horn students must audition on oboe. Their oboe audition will determine membership in the band and the English horn double will be determined by the English horn audition. The English horn audition will contain the chromatic scale and exercise no other scales and no sight-reading.
- All Eb Clarinet students must audition on Bb Clarinet. Their Bb audition will determine
 membership in the band and the Eb double will be determined by the Eb clarinet audition. The
 Eb audition will contain the chromatic scale and exercise no other scales and no sight-reading.
- There are no exercises for Drum Set. The students will play all four styles listed in the audition requirements and sight-reading.
- All Mallet exercises will be done on Xylophone.
- This will be the last year that the 9th & 10th Concert Band will use Rubank's Advanced Method volume II. Some instruments in the concert band have already moved to the 11th & 12th grade books this year. No changes are in store for the 7th & 8th grade band or 11th & 12th grade

III. Issuing Music

EVERY effort will be made to obtain music and instrumentation requirements during the month of August (hopefully this will include Orchestra) so that Music can be mailed to band members on November 15th.

IV. New Procedures

EVERY district will use the same audition procedure this fall.

V. Committee Recommendations on Proposals.

Proposal 1

MOTION: Malcolm/Line that the all-state committee draft guidelines or a philosophy for persons writing the sight-reading material for the All-State Audition. PASSED

MOTION: Venezio/Davenport to refer to the All-State Band Selections Committee. PASSED

• The Committee began developing sight-reading guidelines last year to help the composer level the music. They are still in the developmental stage. We ask that this item remain in committee until the task is completed.

Proposal 2

MOTION: Harris/Henley - The all-state Jazz Band lead trumpet audition should become a separate, non-optional audition, different from the section audition.

Rational: Lead trumpet is a specialized part, much as bass trombone is a specialized part. Yearly, the section displays wonderful jazz style and solid ability, yet seldom if ever does the section have the power and accuracy of a strong lead player. The addition of a strong lead trumpet player would immediately raise the overall quality of the all-state jazz band.

MOTION: Leibinger/Wickersheim to refer to the All-State Band Selections Committee. PASSED

 The committee recommends passing this proposal and has included this in the auditions for 2003-2004. PASSED

VI. Proposals from the Committee

Proposal 3

The committee proposes that the FBA pay for the registration and expenses of the Band Chairs. These members must be with their bands at all times and therefore cannot attend the conference like other directors. Their service is invaluable to the Association. **PASSED**

Proposal 4

TWIRLING/AUXILIARIES - Mary McWilliams

Dear Band Directors,

Thank you for participating in the FBA State Auxiliary Festival. There were so many wonderful units judged by three highly qualified judges. It was a very full two days. In preparing for next year, please consider the following:

Rules must be followed at all state level events. There were a number of events over the time limit. An auxiliary unit cannot perform for over seven minutes, yet some were over ten minutes long! Needless to say, after our third group with a ten minute long show, our already tight schedule was put in jeopardy. I apologize to units who had to bear the brunt of this situation. All events have a time limit and the time limit needs to be followed. I will let the auxiliary judges know that an event over time will have to be reduced a rating. This is not fair to students! I know of some district judges that have told groups at district festivals to decrease the time of their show so they could go on to the state level, but it is often ignored.

In addition to timing rules, there are also rules pertaining to membership of solos and ensembles. A flag solo is a flag solo. Many students did flag for one minute and rifle for another two minutes. That is not a flag solo. If an ensemble lists sixteen performers, and performs at district with fifteen performers, then they may not perform at the state festival with sixteen. I am asking that band directors read the rules carefully. Please allow the performers to read the rules also; they are able to understand the text as well as determine infractions.

I apologize to any unit or band director whose unit did not perform on time due to these rule infractions. I want as many groups and individuals to perform at the state festival. The last couple of years have been quite successful and performers have enjoyed their participation. Please help continue this success by following the rules set forth in the handbook.

PROPOSALS TO THE BOARD

District 1

Jones/Nelson: Proposal to the Executive Board: To clarify in the rules whether chamber groups may be conducted or not.

RATIONAL: The current statements in the handbook are clear regarding the conducting of wind choirs, but are vague concerning chamber wind groups. There is a difference of interpretation among directors about what the handbook means concerning this issue.

MOTION: Leibinger/Schwindt to send to the MPA Committee. PASSED

Jones/Nelson: Proposal to the Music Committee: To review the chamber wind literature on the music list and add more selections as many are currently out of print.

RATIONAL: It is inherently difficult enough to find chamber music to fit a director's strongest players, but becomes almost impossible to put a group together when limited by the few pieces that are available. Chamber wind groups should be encouraged not discouraged by the music selection.

MOTION: Wickersheim/DiFruscio to send to the S&E Committee. PASSED

Jones/Nelson: Proposal to the Executive Board: To have a North and South State Solo and Ensemble MPA.

RATIONAL: One event in the middle of the state makes travel and expense difficult for all groups in the extreme ends of the state. Two sites would encourage more groups to attend. **OUT OF ORDER**

Ewing/Fitzpatrick: Proposal to the Executive Board: To change the criteria of receiving an FBA life-membership pin from "25 consecutive years" to "25 cumulative years". RATIONAL: A person who has been a member of the organization for a total of 25 years deserves this honor regardless if these years were consecutive or cumulative

MOTION: Knight/Williams to have this proposal happen. DEFEATED

District 4

Proposal: Rothgeb/Dorsey That the State MPA be set up on two separate weeks.

Rationale: To avoid Spring Break conflicts that cannot be resolved. **MOTION:** Wickersheim/Coolman to refer to FSMA. **PASSED**

PROPOSAL: That the standard mileage be raised to the national allotment for business expenses (or more) for judges/board meeting expenses.

Rationale: The extreme rise in gas prices warrants a need to raise the mileage reimbursement rate. **DEFEATED**

District 8

1. District 8 recommends that sight-reading, as an integral part of MPA, be re-instated at State Band MPA, and maintained at High School and Middle School District MPA. (submitted by Mike Parks) Motion to submit proposal PASSED Parks/Wunsch

MOTION: Leibinger/Wickersheim to send to the MPA Committee PASSED

2. District 8 proposes that a high school reading jazz band be initiated at the All-State FMEA conference. This is to represent more students from Florida, to help more students learn/practice Jazz literature, and to act as a "back-up" in case any students from the auditioned All-State Band were unable to attend the conference. (submitted by Jim Smisek) Motion to submit proposal PASSED Smisek/Lefkowitz

DEFEATED

- I. In regards to its previous proposal of reinstating sight-reading at the State Concert level (*see below in italics*), District 8 would like to add the following RATIONAL: In a time when reading is such a high priority in the state, de-emphasizing sight reading at state is contrary. Sight-reading coincides with the standards of FCAT reading rationale. Sight reading is a much truer test of teaching and band skills. The directors in our district that attended the state with bands had the following comment/observations: 1. The clinic was a positive for the director as in-service, but the students were uninterested at this point. 2. With no rating tied to the clinic as it is with sight-reading, students are not as motivated to make it relative. 3. There was very little playing or actual clinic. It was mostly talk about philosophy. 4. Kids were bored "they zoned out". 5. It is redundant. Most of us have guest conductors in our band rooms for clinics as part of prep for event. 6. Remember it is called MUSIC PERFORMANCE ASSESSMENT. PASSED Sego/Jennings
- (1. District 8 recommends that sight-reading, as an integral part of MPA, be re-instated at State Band MPA, and maintained at High School and Middle School District MPA. (submitted by Mike Parks) Motion to submit proposal <u>PASSED</u> Parks/Wunsch)
- 3. Heather Harding proposes "FBA add a middle school AA State Jazz Band to the performing ensembles at the FMEA Clinic and Conference. PASSED Harding/Berry

RATIONALE: Student performance in Jazz Band demonstrates skill in all areas of the state and national standards, with special emphasis on improvisation. FBA recognizes that this is important for students in high school, but fails to recognize the importance of this ensemble in middle school. The state and national standards are not limited to high school students.

Research has shown that teachers are more insecure teaching improvisation than any other area of the standards. Adding a middle school jazz band would provide an additional opportunity for teachers to learn about improvisation, while recognizing the talent and abilities of our middle school students who have benefited from strong jazz education programs.

FBA should be an advocate for strong instrumental programs that include jazz education at all levels.

DEFEATED

3. Paul Wilson proposes that "the FBA Executive Board re-approach FSMA to find another way to come up with funds for membership dues raises instead of the 5 cents per entry". PASSED Berry/Jennings
PASSED

District 11

1. Only those auxiliary events classified as A or B be permitted to participate at the State Solo & Ensemble MPA. This would also require these events to be classified as such for District MPA.

Rationale: This corresponds to the requirements of HS instrumentalists at state solo & ensemble and would give auxiliary groups with less experience the incentive to improve their skills.

Boone/Bruce: passed

MOTION: Berry/Erhmann to send to the Auxiliary Committee PASSED

2. Time limits for non-twirling dance ensembles be reduced to 1:45-3:00.

Rationale: This more closely aligns with the performance requirements for other dance team competitions at the state and national levels. (i.e., Florida Dance Team Directors Association, CTC Marching Auxiliaries, University Dance Association, etc.)

Boone/Kraven: Passed

MOTION: Wickersheim/Jenkins to send to the Auxiliary Committee PASSED

3. Auxiliary events at State MPA performing outside the minimum/maximum time limit will have its rating lowered one division.

Rationale: This is in line with the penalty of a band performance being under/over time at marching MPA. If there are no penalties for going under or over time then no time limits should be set.

Boone/Bruce: passed

MOTION: Wickersheim/Jenkins to send to the Auxiliary Committee PASSED

District 12

Motion that Middle School Sight-reading should be two separate sets of music for 1st and 2nd bands at Middle School Assessment. B.Fultz/C.Harris

MOTION: Reaney/Wickersheim to send to the Sight-reading Committee PASSED

Motion that the Association recombine State Solo and Ensemble Assessment with State Concert Assessment and have two sites to accommodate our state. R.Lundahl/S.Alia **DEFEATED**

District 13

1. Handbook Addendum

Section II E. #3 – C

Add – During the sight reading portion of the Concert MPA student stands should be vacant of all materials except those provided by the festival staff. (e.g.: metronomes, tuners, fingering charts, pencils)

Rationale: It is accepted and understood by many that this is the spirit in which the sight-reading is to be performed, but it is not stated in the handbook.

Crocco/McGallagher PASSED DEFEATED

This will be addressed by the adjudication committee with a script for the sight-reading adjudicator.

District 14

To assign Drum Major evaluation to one of the aux. captions in the Marching MPA. **Rational-**Student conductors are currently supported by the FBA. No adjudicators are currently assigned to comment on the drum majors performance. Most non-FBA evaluations have a drum major caption. Drum Majors would like feedback to improve their skill and effectiveness. Carlson-wood/Patsis

MOTION: Leibinger/Wickersheim to send to the Adjudication Committee PASSED

District 15

Nick Pilato suggested to close up loophole that schools are to be members of both F.S.M.A. and F.B.A. to participate in M.P.A. Motion Pilato/Rubio Passed

Rationale: Some bands directors thought they did not have to be a member of FBA to participate. **OUT OF ORDER**

Motion: Dawson/Mile: that State MPA not be scheduled till all district festivals are finished and time is given for forms to be received so that individual needs throughout the state are met. A fair state wide deadline should be given. PASSED. **OUT OF ORDER**

District 16

"The Florida Bandmasters Association State MPA should be held in a venue that is of exceptional quality. Rationale: The State MPA experience should be one of the musical highlights of a student's musical career, and therefore should be held in a hall or venue that promotes such an experience." Brandon/S. Rivero. **PASSED UNANIMOUSLY.**

NO ACTION, THE BOARD AGREES.

B. Wuttke sent a motion through acting Chair G. Walters:

Motion: The Executive Board shall direct the music committee to research, in order to present a report at the upcoming summer board meeting, the feasibility of incorporating all titles found on the FBA Concert Music List indicated as "Significant Literature" onto the Florida State Adopted Textbook List. The report should indicate personnel contacted, and the result of the inquiry.

Rationale: Band Directors should have the option of purchasing music (often the band's "textbook") through school funds. Often administrators are reluctant to use textbook money to purchase music, however, if listed in the Florida School Book Depository listing, they may be more amicable to provide funds for such purchases. Ideally, it would be beneficial to adopt the entire music list, however, this may not be practical as several titles are out of print, and it would not be possible to stock every title on the list.

- f) Page 3, Section E, Heading Change heading to read: "Requirements for Auxiliary/Twirling Adjudicators (Marching Band and Solo and Ensemble)"
- g) Page 3, Section E, #1: Change sentence to read: "Have a minimum of 7 years experience as a Band Directors at either a Middle School, Junior High, High School, or College, or as a teacher of Auxiliary/Twirling groups

ALL THE ABOVE PASSED

IV. Recommendation:

To become certified, Auxiliary/Twirling Adjudicators must attend the Marching Band Certification Seminar, plus one Auxiliary Clinic at Summer Convention every three years. **PASSED**

V. Recommendation:

To become certified, Out-of-State adjudicators must attend an Adjudication Seminar appropriate for their categories, or complete the Interactive CD-Rom for Adjudicator Certification. **PASSED**

VI. Recommendation:

To become certified, College/University adjudicators must attend an Adjudication Seminar appropriate for their categories, or complete the Interactive CD-Rom for Adjudicator Certification. **PASSED**

VII. Recommendation:

District Chairs shall instruct all Solo and Ensemble adjudicators at the beginning of each S&E MPA that they should not be alone in a room with a student. This caution should also be added to the District Chairs Handbook. **PASSED**

VIII. Recommendation:

Persons who are applying to become adjudicators who are not school band directors must include a professional resume' with their application materials. **PASSED**

IX. Recommendation:

The committee reviewed the credentials of the following applicants, and recommends that they be allowed to begin Adjudication Internships in the designated categories:

MOTION: Harris/Henley - The all-state Jazz Band lead trumpet audition should become a separate, non-optional audition, different from the section audition.

Rational: Lead trumpet is a specialized part, much as bass trombone is a specialized part. Yearly, the section displays wonderful jazz style and solid ability, yet seldom if ever does the section have the power and accuracy of a strong lead player. The addition of a strong lead trumpet player would immediately raise the overall quality of the all-state jazz band.

MOTION: Leibinger/Wickersheim to refer to the All-State Band Selections Committee. PASSED

 The committee recommends passing this proposal and has included this in the auditions for 2003-2004. PASSED

Proposal 3

The committee proposes that the FBA pay for the registration and expenses of the Band Chairs. These members must be with their bands at all times and therefore cannot attend the conference like other directors. Their service is invaluable to the Association. **PASSED**

Proposal 4

The committee proposes that the FBA present plaques (large - impressive) to the Band Clinicians for All-State. (6 plaques @ \$50 each = \$300) **PASSED**

MOTION: Walters/Perego to accept the requirements as posted on the web site. PASSED_

MOTION: Knight/Jernigan to remove the following motion at the December Board Meeting from the table. **MOTION:** Wickersheim/Reaney Look into dividing the State S&E into 2 regions (north & south) to accommodate a larger portion of the state, with possible implementation in 2004. **MOTION:** Weaver/Davenport to refer to MPA Committee. **PASSED**

This motion PASSED the Board, and will happen next year.

3. Paul Wilson proposes that "the FBA Executive Board re-approach FSMA to find another way to come up with funds for membership dues raises instead of the 5 cents per entry". PASSED Berry/Jennings
PASSED

"The Florida Bandmasters Association State MPA should be held in a venue that is of exceptional quality. Rationale: The State MPA experience should be one of the musical highlights of a student's musical career, and therefore should be held in a hall or venue that promotes such an experience." Brandon/S. Rivero. **PASSED UNANIMOUSLY.**

NO ACTION, THE BOARD AGREES.

B. Wuttke sent a motion through acting Chair G. Walters:

Motion: The Executive Board shall direct the music committee to research, in order to present a report at the upcoming summer board meeting, the feasibility of incorporating all titles found on the FBA Concert Music List indicated as "Significant Literature" onto the Florida State Adopted Textbook List. The report should indicate personnel contacted, and the result of the inquiry.

Rationale: Band Directors should have the option of purchasing music (often the band's "textbook") through school funds. Often administrators are reluctant to use textbook money to purchase music, however, if listed in the Florida School Book Depository listing, they may be more amicable to provide funds for such purchases. Ideally, it would be beneficial to adopt the entire music list, however, this may not be practical as several titles are out of print, and it would not be possible to stock every title on the list.

Much discussion followed and the vote was unanimous.

PASSED

MOTIONS THAT WERE REFERED TO A COMMITTEE OR OTHER GROUP

Jones/Nelson: Proposal to the Executive Board: To clarify in the rules whether chamber groups may be conducted or not.

RATIONAL: The current statements in the handbook are clear regarding the conducting of wind choirs, but are vague concerning chamber wind groups. There is a difference of interpretation among directors about what the handbook means concerning this issue.

MOTION: Leibinger/Schwindt to send to the MPA Committee. PASSED

Jones/Nelson: Proposal to the Music Committee: To review the chamber wind literature on the music list and add more selections as many are currently out of print.

RATIONAL: It is inherently difficult enough to find chamber music to fit a director's strongest players, but becomes almost impossible to put a group together when limited by the few pieces that are available. Chamber wind groups should be encouraged not discouraged by the music selection.

MOTION: Wickersheim/DiFruscio to send to the S&E Committee. PASSED

Proposal: Rothgeb/Dorsey That the State MPA be set up on two separate weeks.

Rationale: To avoid Spring Break conflicts that cannot be resolved. **MOTION:** Wickersheim/Coolman to refer to FSMA. **PASSED**

1. District 8 recommends that sight-reading, as an integral part of MPA, be re-instated at State Band MPA, and maintained at High School and Middle School District MPA. (submitted by Mike Parks) Motion to submit proposal <u>PASSED</u> Parks/Wunsch

- II. In regards to its previous proposal of reinstating sight-reading at the State Concert level (*see below in italics*), District 8 would like to add the following RATIONAL: In a time when reading is such a high priority in the state, de-emphasizing sight reading at state is contrary. Sight-reading coincides with the standards of FCAT reading rationale. Sight reading is a much truer test of teaching and band skills. The directors in our district that attended the state with bands had the following comment/observations: 1. The clinic was a positive for the director as in-service, but the students were uninterested at this point. 2. With no rating tied to the clinic as it is with sight-reading, students are not as motivated to make it relative. 3. There was very little playing or actual clinic. It was mostly talk about philosophy. 4. Kids were bored "they zoned out". 5. It is redundant. Most of us have guest conductors in our band rooms for clinics as part of prep for event. 6. Remember it is called MUSIC PERFORMANCE ASSESSMENT. PASSED Sego/Jennings
- (1. District 8 recommends that sight-reading, as an integral part of MPA, be re-instated at State Band MPA, and maintained at High School and Middle School District MPA. (submitted by Mike Parks) Motion to submit **MOTION:** Leibinger/Wickersheim to send to the MPA Committee **PASSED**
- 1. Only those auxiliary events classified as A or B be permitted to participate at the State Solo & Ensemble MPA. This would also require these events to be classified as such for District MPA.

Rationale: This corresponds to the requirements of HS instrumentalists at state solo & ensemble and would give auxiliary groups with less experience the incentive to improve their skills.

Boone/Bruce: passed

MOTION: Berry/Erhmann to send to the Auxiliary Committee PASSED

2. Time limits for non-twirling dance ensembles be reduced to 1:45-3:00.

Rationale: This more closely aligns with the performance requirements for other dance team competitions at the state and national levels. (i.e., Florida Dance Team Directors Association, CTC Marching Auxiliaries, University Dance Association, etc.)

Boone/Kraven: Passed

MOTION: Wickersheim/Jenkins to send to the Auxiliary Committee PASSED

3. Auxiliary events at State MPA performing outside the minimum/maximum time limit will have its rating lowered one division.

Rationale: This is in line with the penalty of a band performance being under/over time at marching MPA. If there are no penalties for going under or over time then no time limits should be set.

Boone/Bruce: passed

MOTION: Wickersheim/Jenkins to send to the Auxiliary Committee PASSED

Motion that Middle School Sight-reading should be two separate sets of music for 1st and 2nd bands at Middle School Assessment. B.Fultz/C.Harris

MOTION: Reaney/Wickersheim to send to the Sight-reading Committee PASSED

To assign Drum Major evaluation to one of the aux. captions in the Marching MPA. **Rational-**Student conductors are currently supported by the FBA. No adjudicators are currently assigned to comment on the drum majors performance. Most non-FBA evaluations have a drum major caption. Drum Majors would like feedback to improve their skill and effectiveness. Carlson-wood/Patsis

MOTION: Leibinger/Wickersheim to send to the Adjudication Committee PASSED

Hance/Dubbert: the all-state band audition process creates separate audition materials for Bass Trombone for all bands. PASSED

Rationale:

The technique and range is different enough from the Tenor Trombone to warrant its' own category, i.e. bass clarinet and clarinet.

MOTION: Berry/Wickersheim to send to the All-State Committee PASSED

MOTIONS DEFEATED, DECLARED OUT OF ORDER OR WITHDRAWN

MOTION TO THE EXECUTIVE BOARD: That district chairpersons receive a copy of the S&E Music list on CD ROM.

Rationale: There was a prior motion that District Chairpersons receive the Music List in hard copy. This was prior to all districts having upgraded technology. A CD-ROM version of the list would still provide the security of a "non - hackable" source and would be definitive for answers on questions of the legitimacy of a title from the Web List. This was the purpose of providing District Chairpersons with a hard copy. **DEFEATED**

Jones/Nelson: Proposal to the Executive Board: To have a North and South State Solo and Ensemble MPA.

RATIONAL: One event in the middle of the state makes travel and expense difficult for all groups in the extreme ends of the state. Two sites would encourage more groups to attend. **OUT OF ORDER**

Ewing/Fitzpatrick: Proposal to the Executive Board: To change the criteria of receiving an FBA life-membership pin from "25 consecutive years" to "25 cumulative years". RATIONAL: A person who has been a member of the organization for a total of 25 years deserves this honor regardless if these years were consecutive or cumulative.

MOTION: Knight/Williams to have this proposal happen. DEFEATED

PROPOSAL: That the standard mileage be raised to the national allotment for business expenses (or more) for judges/board meeting expenses.

Rationale: The extreme rise in gas prices warrants a need to raise the mileage reimbursement rate. **DEFEATED**

2. District 8 proposes that a high school reading jazz band be initiated at the All-State FMEA conference. This is to represent more students from Florida, to help more students learn/practice Jazz literature, and to act as a "back-up" in case any students from the auditioned All-State Band were unable to attend the conference. (submitted by Jim Smisek) Motion to submit proposal <u>PASSED</u> Smisek/Lefkowitz

DEFEATED

3. Heather Harding proposes "FBA add a middle school AA State Jazz Band to the performing ensembles at the FMEA Clinic and Conference. PASSED Harding/Berry

RATIONALE: Student performance in Jazz Band demonstrates skill in all areas of the state and national standards, with special emphasis on improvisation. FBA recognizes that this is important for students in high school, but fails to recognize the importance of this ensemble in middle school. The state and national standards are not limited to high school students.

Research has shown that teachers are more insecure teaching improvisation than any other area of the standards. Adding a middle school jazz band would provide an additional opportunity for teachers to learn about improvisation, while recognizing the talent and abilities of our middle school students who have benefited from strong jazz education programs.

FBA should be an advocate for strong instrumental programs that include jazz education at all levels.

DEFEATED

Motion that the Association recombine State Solo and Ensemble Assessment with State Concert Assessment and have two sites to accommodate our state. R.Lundahl/S.Alia **DEFEATED**

1. Handbook Addendum

Section II E. #3 – C

Add – During the sight reading portion of the Concert MPA student stands should be vacant of all materials except those provided by the festival staff. (e.g.: metronomes, tuners, fingering charts, pencils)

Rationale: It is accepted and understood by many that this is the spirit in which the sight-reading is to be performed, but it is not stated in the handbook.

Crocco/McGallagher PASSED DEFEATED

This will be addressed by the adjudication committee with a script for the sight-reading adjudicator.

Nick Pilato suggested to close up loophole that schools are to be members of both F.S.M.A. and F.B.A. to participate in M.P.A. Motion Pilato/Rubio Passed

Rationale: Some bands directors thought they did not have to be a member of FBA to participate. **OUT OF ORDER**

Motion: Dawson/Mile: that State MPA not be scheduled till all district festivals are finished and time is given for forms to be received so that individual needs throughout the state are met. A fair state wide deadline should be given. PASSED. **OUT OF ORDER**

Mr. Hart motions to ask FMEA to move the FMEA Clinic-Conference one week later.

Ms. Pantke seconds. Motion carries. **DEFEATED**

To extend the entry deadline for State Concert MPA from 7 to 10 calendar days. **DEFEATED**

MOTION: Stark/Norton That District Chair's be paid an honorarium at a rate of \$10.00/hr. for administration of MPA's not to exceed actual adjudication time.

Rationale: Custodians, Piano Tuners, Adjudicators, etc. all are compensated for their time at MPA's. Chairs are expected to pull double duty with their band/students and office duties without compensation. **DEFEATED**
