This form must accompany <u>any</u> all-state forms. If this form is not filled out, the students will not be permitted to audition. <u>All directors must work one shift</u>. Directors notice that there are changes in the all-state script.

The all-state student fee is \$10.00 per entry. Please advise bookkeepers and use these minutes as your assessment fee proof.

Small Schools and Middle School Honor Band Forms are also accessible from the web page and should be filled out, signed by you and your principal, and sent to the appropriate chairperson on the bottom of the form. Please be aware of the deadlines on the form. A \$15.00 fee must accompany each application – <u>not</u> each student nomination.

Classification forms must be sent to lan Schwindt at Titusville H.S. by October 15, 2002. This form must list the number of students in your school, not in your band program. To apply for reclassification, you must fill out the appropriate box in the middle of the form. The board will vote on this and you will be notified of the results. If permission is granted, you <u>must</u> play that grade level of music. You may re-classify at the end of the semester schedule.
