Rationale: Much of the current (nd past) sight-reading music is inappropriate for the classification level and contains errors that create unnecessary problems during sight-reading.

## Item 13: Proposals to the Executive Board

B. Wuttke sent a motion through acting Chair G. Walters:

Motion: The Executive Board shall direct the music committee to research, in order to present a report at the upcoming summer board meeting, the feasibility of incorporating all titles found on the FBA Concert Music List indicated as "Significant Literature" onto the Florida State Adopted Textbook List. The report should indicate personnel contacted, and the result of the inquiry.

Rationale: Band Directors should have the option of purchasing music (often the band's "textbook") through school funds. Often administrators are reluctant to use textbook money to purchase music, however, if listed in the Florida School Book Depository listing, they may be more amicable to provide funds for such purchases. Ideally, it would be beneficial to adopt the entire music list, however, this may not be practical as several titles are out of print, and it would not be possible to stock every title on the list.

Much discussion followed and the vote was unanimous.

#### Item 14: For the Good of the Association

Best Wishes/Prayers to Brian and his family for Brian's speedy recovery.

G. Walters mentioned that despite Brian's illness, the Killian Band I received straight superiors at State. His students are to be commended for their efforts during this trying time.

Congratulations were offered to S. Gardner and J. Normandin for being selected as conductors for this years Miami-Dade County Superintendent's Honors Bands.

- N. Bisco thanked C. Leibinger and the district for mentoring first year teachers.
- C. Leibinger mentioned the summer convention and the Masterworks Series, and stated that everyone should bring their instrument and play in the band.
