E-mail from Charles Williams at Marathon High School requesting permission to perform at the District 16 Marching MPA. Motion Lowell Thomas/Tyrone O'Neil to allow Marathon High School to perform as requested. **PASSED** pending receipt of paperwork and payment of assessment fees.

A letter from Coral Reef Senior High offering to host the District 16 High School Concert Band MPA was read. No other letters were presented. **PASSED.**

Letters from Palmetto Sr. and Southwest Miami Sr. were presented regarding their band's performance time at the District 16 Marching MPA. Motion Steve Gardner/David Toledo to allow the chairman to take such requests into consideration when scheduling the event. **PASSED.**

Item 6: Unfinished Business

Formation of Committees: Adjudication Committee-Daryl Clark and Malena Calle will chair. Brian Wuttke and George Walters will be members

Marching MPA Committee-Steve Gardner and John Normandin will chair. Other members include Doug Jordan, Jeff Gross, Malena Calle and Jason Hatfield.

Concert MPA Committee-Steve Rivero will chair.

Mr. Wuttke charged each committee chairperson to hold meetings as soon as possible, and urged any interested members to contact the respective committee chairs if interested in serving.

Item 7: Committee Reports

No reports at this time. Committees have just been formed. Meeting dates, times and locations will be announced. All committee meetings are open to the general membership.

Item 8: New Business

The chairman reported numerous concerns relating to security and logistics had been conveyed by the membership. Motion Tyrone O'Neil/Lowell Thomas for Mr. Wuttke to hold a joint meeting with M-DCPS Police and the M-DCPS Music Office to relay the district's concerns. **PASSED.**

Discussion ensued concerning the logistics of the University of Miami and Florida International University Band's performance at our Marching MPA. Membership agreed that these performances benefit our students (quality performances) and the colleges (recruiting). Members mentioned that the college bands do interfere with the final high school bands in the warm-up area. Discussion was also entertained concerning which band would perform in the afternoon and which would perform in the evening. Consensus was to allow the chair to discuss with each college band director their performance times and warm-up logistics.

Mr. Wuttke asked members if they were happy with the current Marching MPA format, including the current policy of not announcing ratings. No discussion ensued; there will be no changes.

No location has been secured for Middle School Concert Band MPA. The chair would like to have a North and South site. Several members mentioned that their schools currently have classes in their auditoriums. Malena Calle urged members to come forward and make the Middle School MPA a quality experience.

Joselyn Milton-since UM & FIU want to use Marching MPA to recruit, perhaps they should donate halls for the Middle School MPA Melton Mustafa-the performing arts center in North Miami Beach is a possibility. He will check on it. Nate Bisco and John Normandin will check into the possible use of their schools.
