Also, please send a hard copy and a floppy disc or e-mail to Gray. NEW: Each student must turn in an All-State Concert Participant's Contract prior to auditioning. There is a form in your packet. Please copy and distribute to your students. Please mail these forms with your application. Also, please remember that we will need to use recording equipment from each band. You will be contacted concerning this.

There was a mock All-State Audition held.

>7<sup>th</sup>-8<sup>th</sup> Grade Honor and Small School Honor Band forms are due to the respective chairmen of each band (listed on application) by Sept. 25<sup>th</sup>. Be sure to include your check for \$15.00 per school. All-State Concerts Participant's Contracts must also be sent with applications.

>Marching Band MPA – Saturday, October 12, @ Tate HS. Entry forms must be postmarked by September 15. LATE FINE: \$50.00 / \$100.00 after the 8<sup>th</sup> calendar date. (payable to FBA). Schools must have a current Classification Form on file to participate. Joe Hooten encouraged all participating bands to submit a photo of the band and fill out the information sheet for the program. Tate HS will video your show for \$5.00 if you provide the tape or \$10.00 if they provide the tape. The scheduling will be done by the size of the bands. MOTION: (Knight/Dunn) The ticket prices will remain the same as last year (\$7.00 for premium seating/ \$6.00 for general admission/ \$2.00 for group/ senior citizens 65 and over admitted free) Passed.
