Item 14: Proposals to the Executive Board

Motion Hillbery/Normandin that <u>Bass Trombone</u> should be added as a separate audition category for the 11th and 12th grade Symphonic Band. <u>Rationale</u>: There are an increasing number of trombone students in this age group who are electing to specialize in performing on the bass trombone as opposed to the tenor trombone. The equipment and sonority of these two instruments are different and the level of literature being selected for the Symphonic Band and the 11th and 12th grade Orchestra should be performed on the proper instrument. The audition should have scale range requirements and prepared exercises that appropriately demonstrate the student's ability to perform Bass Trombone literature. **PASSED-UNANIMOUSLY**

Motion E.Rivero/B. Lopez to add an Auxiliary Percussion portion to the All-State audition requirements. <u>Rationale</u>: Jazz music today often requires specialized auxiliary percussion instruments as well as a specialized auxiliary percussionist to properly perform the literature as written on the printed score. **PASSED-UNANIMOUSLY**
