- b. Classification Forms
  - 1. Due October 15 to District Chairperson. Don't forget principal and director signatures.
  - 2. Senior High report grades 9-12 OR 10-12; Middle School report grades 7-8
  - 3. \$50.00 fine for submitting form late and \$100.00 fine on the 8<sup>th</sup> calendar day. Payable to FBA.
- c. All-State Auditions (white sheets)
  - 1. September 13, Piedmont Lakes Middle School
  - 2. Application forms and checks due to Becky Sego on August 27. Forms must be typed!
  - 3. Fee: \$15.00 per audition slot (\$10.00 state, \$5.00 recording fee)
  - 4. Directors are required to be there when their students are auditioning and to assist with the auditions as usual. These jobs include monitoring rooms and reading scripts.
  - 5. Middle school students will be scheduled in the morning, high school students in the late morning and afternoon. Any special requests needed (for student and/or director scheduling) should be turned in with your applications.
  - 6. Please screen students carefully. Do mock auditions.
  - 7. Please not the change in audition requirements from previous years. (i.e. lead trumpet & drum set for jazz, piccolo, Eb Clarinet, English Horn.) Next year, Rubank's Advanced method will not be used for any high school auditions.
- d. Small Schools Honor Band and 7<sup>th</sup> & 8<sup>th</sup> Grade Honor Band Nominations:
  - 1. \$15.00 per school. Application is in packet or on web site. Due Sept. 25
  - 2. Completed application forms needs to be returned to respective chairperson, not to district chair.
  - 3. <u>Clarification</u>: No contract needed to apply; however, there is one needed if student(s) is selected to the ensemble. Also, students will not be accepted, just to have the nominating school represented.
- e. Marching Band MPA November 8, 2003, at the Florida Citrus Bowl
  - 1. Entry form due to chair by Oct. 15 NO assessment due at this time.
  - 2. \$50.00 fine for submitting form late and \$100.00 fine on the 8<sup>th</sup> calendar day after the deadline. Payable to FBA. Schools may not enter on the 15<sup>th</sup> day after the deadline. Schools must also have classification form on file to participate in Marching MPA.
  - 3. All bands must be present for entire festival per district decision.
  - 4. Supervision of students needs to be enforced by directors.
  - 5. Middle school national anthem band will be co-chaired by Jody Wunsch and Keith Nichols. Reminder that 8<sup>th</sup> graders will be asked to perform first. Seventh graders will be asked only after determining the number of 8<sup>th</sup> graders participating.
  - 6. American flag: Please follow national guidelines for the handling of our country's flag. District Chair has permission to lower a bands rating if the flag is mistreated.
- f. New Festival program will replace the old one. There will be \$20.00 added to your assessment.
