Item 15: Suggestions to State Committees

Middle School Participation at FMEA convention – Concerns were expressed about the location of the middle school band rehearsals. Several directors feel that the middle school students should be rehearsing at the convention center. Rationale includes:

- There were some discipline issues at the hotels this year, but the middle school directors were across town, and had difficulty getting back and forth to deal with them.
- Middle school students are much more dependant than high school students, and need their teachers near by; in many cases the band director is also serving as chaperone.
- Middle school students miss out on much of the "All-State experience." They are unable to see concerts and the exhibits due to rehearsal locations and time-frames.
- One director mentioned his students seemed disappointed all they did was rehearse for many hours, and play a concert, they did not get to experience what high school students did.

- The distance between the middle school students and their directors during the day causes serious liability issues for the schools. As their teachers, we the directors, are ultimately responsible for the safety and well-being of our students.
- The state of band programs in Florida relies heavily on the success of our middle school programs. We urge the Executive board and the appropriate committee to look into this concern, and help us create a better experience for middle school participants.
