Lavay/Bares

Motion: The deadline for concert music special permission be moved to November 1st.

Rationale: Directors are busy with many activities during the fall and need more time to properly assess the abilities of their students for concert season.

Bares/Lavay

Motion: Remove from Handbook: page 5, EXCEPTION #3 "the same band director must teach in all school affected. [NOTE: All schools affected must be served by only one band director.]"

Rationale: Many directors team teach between the middle school and high school programs. This dual responsibility should be sufficient.

Bares/Sickon

Motion: Remove from Handbook: page 5 "A class "C" or "CC" school may use 7th, 8th, and 9th grade students from a separate junior high or middle school in the same town under the following provisions". Replace with: "any school may use 7th, 8th, or 9th grade students from a separate jr. high/middle school feeder under the following provisions".

Rationale: Times have changed and programs from all levels of classification are facing enrollment and remediation issues that the use of jr. high/middle school students can alleviate.

Bares/Lavay

Motion: That the executive board provide a rationale as to why a proposal to the executive board was defeated. Rationale: The membership needs to understand why a proposal was defeated.
