Tagliarini/Salmon:

Motion: Both boxes of middle school sight reading should include music for MD and MC bands. Rationale: Many directors bring second and third bands to MPA. It is discouraging to these younger,

less experienced students to be expected to sight read the same level of music as the advanced groups. It would be more rewarding for these students to be expected to sight read music at their

level of ability and playing experience.
