Item 1: Call to Order and Introductory Remarks

Mr. Robert Gonzalez announced that he is the director at Coral Way K-8 and he is new to our district. Mr. Sterling Jones, director at Glades Middle School also announced that he is new to our district. Both were welcomed by the members present.

Mr. Erich Rivero thanked Mr. Leo Altimiranda and Mr. Lowell Thomas for hosting the Middle School MPA this year. Ms. Malena Calle also thanked Mr. Leo Altimiranda.

Item 6: Music Advocacy Issues with FBA and FSMA

Concerns about the middle school physical education requirement are causing worry within the District. Erich Rivero encouraged directors to have students write a letter as their essay final exam to the school board on this issue. Erich Rivero also would like to try to have an advocacy group that would focus on this issue and others that may arise.

Item 7: Unfinished Business

CD recorders need to be purchased by our district. Mr. Erich Rivero suggested the Superscope Technologies "Voyager Upgrade" System. The package includes the PSD300P, 2 audix condenser microphones, 2 quick-loc microphone stands, headphones, carry case, 50' microphone cables, 10 blank CD-R discs in jewel cases, and 25'extension cord. Total package costs \$1,199.00.

Erich Rivero informed the District that Mr. David Hillberry, owner of Burning Bush Recordings also recommends the purchase of the recording package. He has also recommended purchasing a hard shell case for the unit for an additional cost of \$125.00. It will help keep the units in good condition over the years. Mr. Hillberry has also extended his services by coming to the District's first meeting of the 2006-2007 school year to demonstrate the use of the CD recorders.

Mr. Lowell Thomas asked how long it would take to finalize the CD's. Mr. Erich Rivero said it should only take 2 to 3 minutes.

Mr. Manuel Camacho asked if there was a deadline to purchase the CD recorders. Mr. Erich Rivero responded that the company would honor the price and hold it for the District.

Mr. Manuel Camacho motioned to accept the CD recorder package from Superscope Technologies. Ms. Jennifer R. Jimenez seconded the motion.

Item 9: New Business

Mr. Erich Rivero informed the members that Mr. David Hillberry, owner of Burning Bush Recordings, was offering his services to record the Middle/High School Concert Band and Jazz Band MPA's for 2007. The recording fees would remain the same and each director would receive a CD of their band and a second CD would be recorded for FBA archives. Mr. Hillberry is already aware of the MPA dates for next year.

Mr. Lowell Thomas motioned to have Burning Bush Recordings continue to record the groups at Middle/High School Concert and Jazz Band MPA.

Manuel Camacho seconded the motion.

Mr. Erich Rivero informed the association that Miami Killian High School is interested in hosting the High School Solo & Ensemble and Jazz Band MPA next year. Mr. Rivero explained that Miami Killian is more than willing to allow the District to utilize their Kawai keyboards and pianos. In addition, Miami Killian would be more than willing to accommodate the Auxliaries in the gymnasium. Miami Killian requests assurance that FBA would be responsible for any damage. Mr. Rivero provided a letter with his request.

Mr. Leo Altimiranda is also interested in hosting the High School Concert Band MPA at Miami Senior High School next year. Mr. Altimiranda did not have a letter in hand to present to the Executive Board.

Mr. Steve Rivero made a point that a letter must be present at the meeting, therefore he **motioned to table this issue** until the August meeting when a signed letter can be presented. Mr. Lowell Thomas **seconded** Mr. Rivero.

Mr. Steve Rivero brought up the topic of pictures at evaluation. He was pleased that the picture for his band was taken on stage instead of on bleachers. Having the pictures taken on stage reflects professionalism of the group. Ms. Malena Calle interjected that by taking them on stage; it reduces the amount time wasted during MPA. Mr. Erich Rivero agreed that is would be possible to take pictures on stage, however, it must be timed correctly to allow students the opportunity to complete picture order forms. Mr. Steve Rivero said to have the forms sent to the directors ahead of time to give to the students. Mr. Berman Lopez agreed with Mr. Rivero.

Mr. John Pace motioned to have pictures taken on stage after MPA performance.

Mr. Berman Lopez seconded the motion.

Alan Parker, a representative of Jolesch Photography also sent an agreement form to Mr. Erich Rivero regarding pictures for MPA's which would allow them to be the exclusive photographer for the events.

There was a presentation given by Mr. Roger Topalian, photographer with 21^{st} Century Photography. He presented a bid for 10X16 group shot (panoramic view) taken either on stage or on bleachers. Each director would receive an 11X14 framed photo complimentary. The cost of each shot would cost \$20.00 each.

A discussion followed the presentation regarding which Photography Company would be the best to have at MPA's next year. The membership discussed the pros and cons of both companies. Mr. John Pace **motioned** to table the decision on which photography company the District should use. Mr. John Normandin **seconded** the motion. Motion was tabled by unanimous vote.

Mr. John Normandin questioned whether the middle school MPA assessment was lost or if there would be a chance of reimbursement. Mr. Erich Rivero stated that Mr. Duane Hendon said the assessment fee could not be refunded; however, the monies paid could be credited for next year.

Mr. Paul Smith stated that all MPA events ran smoothly; however, there were not enough busses to transport groups. Mr. Erich Rivero telephoned charter bus companies to see if they would be able to transport groups. Mr. Rivero was able to find a bus company charging \$300.00 per bus, however, Mr. Jim Smith, Music Supervisor for Miami-Dade County said it was too expensive and did agree with providing funds for the charter bus.

Mr. Lowell Thomas suggested sending someone to the District music office to assist with bus scheduling for MPA's. The bus schedule should correspond to the performing schedule. Mr. John Normandin requested the same, however, to work into the schedule some listening time for the groups. This should also aid in bus transportation for MPA's.

Motion: Mr. John Normandin: To form a committee to assist with the scheduling of bus transportation for MPA's.

Mr. Fernando Diez **seconded** the motion.

For example, a band might earn an Excellent rating by the Marching & Maneuvering adjudicator for a number of reasons; however, both Music adjudicators find the ensemble to be Superior. Moreover, if Auxiliary is already not a part of the existing criteria, then no visual caption should be a factor.
