 - (L.Reaney/Roan) Motion to research different photographers to find a more suitable photographer by the District's standards, since the current contract is ended, pending the explanation of current photographer's substandard service. (Passed)
 - A healthy discussion occurred concerning proper etiquette from Band Directors and their affiliates at MPA venues. This discussion triggered the following motions:
 - a. (Roan/Dahlberg) District should assess a \$100.00 fine to any Director in breech of an ethics code violation. (failed)
 - b. (Roan/Porter) Motion that all ethics code violations will be handled by the Chairman at his or her discretion to be accompanied by a letter to the offending Director and/or Director and his or her Principal detailing the infraction. (Passed)
 - Joel Pagan commented that a number of problems faced at MPA venues could be avoided if directors would simply read their handbooks!
 - Tommy Ferlazzo commented on the overall effectiveness of the Marching MPA site (i.e. distractions from Hospital Ambulance, sirens, Helicopter, Air Planes, etc.). Emphasized that the performing venue of our Marching MPA's should be just as important as our Concert MPA's.
