- Bill Reinecke presented information from Commentary Committee regarding Middle School concert MPA
- The committee recommends that we procure a commentator rather than a clinician for only Middle School Concert MPA for the following reasons:
 - The attention span of students and the lateness of some performances make a clinician not feasible.
 - High school directors have the opportunity to commentary if they qualify for State; middle schools do not currently have the
 opportunity; therefore it would benefit the most people to do this with middle schools this year.
 - It is not in our budget to hire the extra clinicians for each MPA event. It could be budgeted for the future.
 - Rationale is further explained in the report submitted by the committee.
