Solo and Ensemble (Keys location)

Jazz Band MPA

Thursday, February 21 at Ransom Everglades. Assessment is \$11 per student. Forms are due January 19th. Kudos to Cathi for organizing the event and Bobby for lining up the judges. (One more judge may be needed.)

Full Band MPA

March 13 (Florida Christian School) and March 14 and 15 (Coral Shores High)
Assessment is \$11 per student plus a flat \$30 recording fee. Forms are due February
1st. You can enter a "TBA" if necessary. Bobby is checking on a professional
photographer. Everyone agreed that pictures are a nice touch and much appreciated
by students and parents. They will be taken after the on-stage portion of the event.
Cathi is checking on recording with David Hillberry. It was difficult to hear judges'
comments last year. A suggestion was made to use CD recorders, but can adjudicators
work the equipment? The higher tech equipment means easier track access for review
post-performance and a clearer transcription of the performance. But student
helpers during the process are not appropriate. Bobby will check to see if current
judges are able to use the CD recorders. But for the time being, we will probably use
the cassette system already in place.

State MPA

According to the handbook, band participation is for overall superior ratings and solo/ensemble participation is for grade 5 or higher repertoire. Solo memorization will qualify for a superior-with-distinction. Entries are due 10 days after 5 & E which is February 19 for our district (based on the Monroe County school 5 & E event).
