There was discussion regarding the amount of money being paid to band directors who host events as the "administrator". Clarification – not all directors who hosted events were paid. The amount for this was posted in the "other" category (77), which we are over budget by \$2500 due to this not reflected in the budget handed to Dell from the previous chair. This is reflected for next year if the district chooses to up hold this policy, which explains part of the \$500 increase in our budget. Our district could save at least \$2000 if this procedure were to be changed – as a result our assessment could drop. If we keep status quo, then our assessment will most likely remain the same, if we bring in the same gate at marching MPA.

In the bank: \$5,506

As directors we will need to find a way to better control the environment of the performance area. We need to look into finding a new warm-up room and case storage area.
