## Item 4: Treasurer's Report

- We currently have \$526.03 in our checking account.
- We are awaiting a check for \$21,495.38 from FSMA.
- Once again you will be receiving a copy of our budget at each meeting. You might notice that our operating budget has increased from \$73,000 at the last meeting of the year to \$74,370. The reason for the \$1300 increase is because the mileage rate paid for FBA activities went from \$0.45 per mile to \$0.50 per mile and the assessment paid to the FBA office was raised from \$0.80 per entry to \$0.90 per entry. Duane adjusted our budgets for this school year to reflect the two increases.

## Item 6: Music Advocacy Issues-FBA/FSMA

#### **Bill 610: Physical Education**

- Students in grades 6-8 will be required to take one class period per day for one semester of each year beginning in the **2009-2010 school year**
- The PE requirement can be waived if: the student is enrolled in a remedial course, the student's parent requests in writing to enroll the student in another course, the student is participating in physical activities outside the school day equivalent to the mandated requirement
- Each school district must notify the student's parent of the option related to this requirement BEFORE scheduling the student to participate in PE

#### Bill 1712: Relating to Ethics in Education Act

- If you are convicted of a felony you will forfeit your retire benefits. Basically, anything much more than a traffic violation
- If a teacher resigns from a position in lieu of termination, the school board is required to report the misconduct to future employment references if the misconduct affects the health, safety, or welfare of a student
- School board members will be penalized for not disclosing misconduct
- Charter and private schools are included in these provisions if they receive scholarship students
- A teacher will be suspended if they know of and fail to report actual or suspected child abuse or misconduct which affects the health, safety, or welfare of a student

#### Bill 1908: Relating to Designation of High School Grades

- Language related to the fine arts credit for high school graduation to include "practical arts courses that incorporate artistic content and techniques of creativity..."
- In the 2010-2011 school year the FCAT writing should not be earlier than March 1, and the rest of the test not be administered earlier than the week of April 15
- A statewide standardized end-of-course test be administered in the last two weeks of the course
- School districts will not be able to suspend regular school classes to administer practice tests or other test-prep activities for state wide assessment

#### Amendment 5 – Has been removed from the November Ballot. An appeal is expected.
