\*\*\*Remember that with the way we schedule for Concert MPA in our district... the sooner you turn your forms in the more likely you will be to receive your first choice in performance date. This year all of your paperwork and assessment check must be turned in with no mistakes in order for your school to be considered in their first choice. Hannah be looking for every paper to be present with the correct signatures, assessment form, and assessment check including the recording fee for the amount of groups you will have performing. Once everything is turned in correctly she will put your name in order on a list. Then she will go through the list starting at the top and give the school their first choice, and so on. Once a day is full she will give that school their second choice, if that day is full the school will get their third choice. If you want to get your first choice of performance dates she encourages you to turn your forms in early!

Discussion: Best Practices for Marching Band and the motion.

- Several talking points were raised including the following;
- If we (FBA) do not address this issue, then FSMA could possibly create a rule that might not appeal to Band directors.
- Reasons for Limiting to 3 plus 1 marching competitions
  - Excessive Practice Time
    - Some states limit the hours a band can practice just as the football teams have limitations.
  - Excessive fees (Required fees)
  - Travel cost

There needs to be some clarification to the motion as to what the 4 events are: 3 competitions and MPA. Does a parades count as a competition? If a band takes a Bowl Game trip (or something like that), is that considered a competition?

- Who will Police band participation?
- What about bands that participate in competitions out of state?
- The issues of how band competitions should be handled by the band director and the principal. They should be responsible for whatever they decide to do.
- FBA should make a recommendation rather than a mandating and telling directors how to run their programs.
- Students should not be penalized (removing S&E or other MPA opportunities).
- From a data standpoint. What data has been brought forth that supports the limitation of band competition. It seems that it is a school based decision and what works at one school, may not work at another. By setting a limitation are we lowering the bar for our band achievement?
- District 8 will defeat this motion at the board meeting

#### Item 13: Proposals to the Executive Board

**Motion:** Direct FSMA to form a committee to research "Best Practices" for marching band participation, finances, rehearsal, and performance time commitment. Members of the committee should include members of the FMEA Research Committee, school administrators, and currently active band directors who form a representative cross-section of band programs throughout Florida. A final data-driven and research-based "Best Practices" document shall be provided to the music teachers and principals throughout the state as a guide for balancing the function of the marching band in the context of the overall band program. (F.Jennings/Eaddy)

Rationale: The FSMA Policies for Governance states:

The purpose of the [FSMA] board, on behalf of the member schools, is to see to it that FSMA achieves appropriate results for appropriate persons at an appropriate cost, and avoids unacceptable actions and situations.

- The board will govern with an emphasis on
- a) outward vision rather than an internal preoccupation,
- b) encouragement of diversity of viewpoints,
- c) strategic leadership more than administrative detail,
- d) clear distinction of board and executive director roles,
- e) collective rather than individual decisions,
- f) future rather than past or present, and
- g) proactivity rather than reactivity.

Furthermore, the "Ends of FSMA" are defined:

The purpose of FSMA is high quality, broad based, thriving music programs in member schools. In accomplishing this purpose, the following areas are of importance:

\* Models for and tools to recognize best practices in excellent music programs

"Best Practices" for marching band is often a nebulous and unclear area of discord for band directors in various types and sizes of school throughout Florida and the country. As this issue becomes more contentious, FSMA has clearly stated its own role to provide "strategic leadership" that is "proactive" and that puts an emphasis on "diversity of viewpoints." Therefore, it is the role of FSMA to research and publish what truly are the "Best Practices" for marching band and its role in the overall band program. It is the job of FSMA to take the lead to rationally and objectively analyze the issue and provide leadership. Punitive and arbitrary designations of field show participation do not provide a comprehensive or specific direction to guide directors. A **research-based** guide for Directors and Principals will serve as an invaluable resource for all areas of dispute on this topic.
