# ITEM NO. 5.-- ADVOCACY ISSUES WITH FBA AND FMEA

Cindy Balistreri, Fine Arts Program Specialist, The School Board of Sarasota County presented the district with the issues that post a threat music education. As a representative of the FMEA, she brought a few key issues that the district must be aware. She stated that the FMEA has organized a group of realtors, businessmen and others, along with James Perry to interview each person running for state office to see where each person stands on fine arts education. She also stated that there are constitutional amendments in the upcoming elections that the FMEA urges a NO vote:

- Eliminating State Required School Property Tax and Replacing with Equivalent State Revenue -- Amendment #5
- Religious Freedom -- Amendment #7
- Public Funding of Education -- Amendment #9

Cindy will be emailing every one a copy of the amendments with further explains why the FMEA urges a "no" vote.

In effort to "Go Green" the bulletins will only be posted on the FBA web site as they have been in the past. You may request a hard copy by emailing or calling Duane Hendon.

Beginning July 31, 2009, any adjudicator not currently certified nor current with their recertification must complete the appropriate seminar, or their name will be removed from the adjudicators list. From that point forward, the list will be updated annually on July 31 to remove the names of adjudicators who are not in compliance

Changes for Section III.E.c.2 in the By-Laws concerning Concert MPA:

- 1. The director who will conduct the march has three minutes to study...
- 2. The director who will conduct the concert selection has five minutes to study...
- 3. Only the director who will conduct the band may instruct the students during the preparation time prior to the performance of each piece.

The Otto J. Kraushaar Award requirements have been changed. Now reads: presented to Senior High School Bands for achieving Superior ratings from all adjudicators and an overall rating of

Superior in District Marching and Concert, State Concert and Sight-reading Music Performance Assessments.

Changes in the classification in the Sight Reading Music Class to be: Middle School: Class MA-Reads-MA, MB Class MB-Reads-MA,MB Class MC-Reads-MC (handbook has MC/MD) Class MD-Reads-MD (handbook has MC/MD)

Roll of Distinction concert at Stetson University on November 15 for Henry Fillmore.

Hall of Fame concert at Stetson on November 16 for Phil Wharton and John Gorecki.

Jim Bruce presented a proposal being discussed at the FBA board meetings which proposes a limit of competition that a marching band can perform during the fall semester. Mark Spreen – The members of the FBA presented "The Best Practice" paper which is inline with the philosophy of the FBA. This was brought forward by administrators had concerned on the number of hours spent on multiply of marching events and the possible exploitation of student. Members of the district discussed the ramification of this issue. Jim explained that the purpose of this meeting was to gather each concern to present to the board at the next meeting. He further explained that the issues, before it takes effect, would need to be voted by the entire FBA membership before going into affect. The discussion was tabled until the next meeting.

# ITEM NO. 8.-- COMMITTEE REPORTS

Linda Boone, Auxiliaries Committee Chair

She read the changes made to existing requirements:

- Dance solos are now a minimum of 1 minute and 45 seconds with a maximum of 3 minutes.
- Performers will be allowed to perform two equipment solos, provided that the equipment is different, that the solo guidelines are met, and that the overall limit on number of solos/ensemble is not exceeded.

She also stated there is a need for more auxiliary adjudicators.

Greg Nielsen - Recording Committee

The cost of recording at all-state auditions have increased. Greg asked for an increase of \$5 to the audition fee per student in order to cover the cost.

Motion to increase the audition fee per student to \$20 Boone/A Bradley Motion Passed.
