Help lower assessments by performing and parent attendance at marching MPAs

- -Downtown memo: All podiums must have front and side railings on podiums over 18"
- -Show length: 5-10 minutes starting from the first note, ending on the last note
- -Student-run performance, no director, staff, etc. warm-up on the field of any kind (warm-up limited to 1 minute)
- No adjusting sound equipment or talking to the students after performance has begun.
- -Any rules infractions occurring will result in the lowering of the overall final rating by one division

Remember that middle school directors and high school directors, that are waving not to participate in MPAs, must volunteer or send a representative. If not, pay the \$1.50 higher per assessment entry fee.

2.0 Activities contracts – make sure we follow the rules set for us. This includes attendance and tardy policies as defined: 10 absences (excused or unexcused) and 20 tardies. Students can appeal by saving their admits and notes from the doctors and attach to appeal form. Process takes about two weeks.
