As student enters, please confirm student data on the card (name, instrument, band they are auditioning for) and code (which must match the code on the CD). Check level before they start to play. Read script loud, clear and slow. Once they are done, remember to finalize the CD and check to make sure it recorded. "Just say thank you" without embellishment, as they leave.
