- All-State Auditions
  - o Be sure you and your students have checked for corrections on the FBA web site.
  - o Auditions will be held on Saturday 9/14 at the FI. West Coast Symphony Center.
  - o Directors MUST be present for students to audition.
  - o The form is available on-line and must be postmarked by 8/31 or in hand by 9/2 with a check for \$10 per entry (payable to FBA District 11). \$50 late fee 9/3-4.
  - o No one auditions without a signed All-State Participant's Contract.
- Small School Honors Band
  - o Grade 7 & 8 nominations are due September 25 (\$15 check per school to FBA #11)
  - o Include signed All-State Participant's Contract for each student listed.
- Classification Forms are available on-line and are due (in hands) October 15. (see Item 6 above)
- Marching MPA
  - o Motion for the location to be Manatee High School, C. Evans/O. Bradley: PASSES
  - o Admission will be \$5 and children 12 and under will be admitted free with an adult.
  - o Middle Schools participating in the National Anthem are permitted one chaperone for every 10 students (chaperones will enter with the students and wear ID provided by their school)
  - o There will be a reserved viewing area for directors.

o Each school may have one (1) person videotape their school from the taping area. A video ID badge will be provided to each school in the MPA packet.

O <u>Motion</u> Video production will be provided by Foot Note Productions. Each director will be given a wide angle tape of their band performance the evening of the festival. Edited, two-camera versions with enhanced sound quality will also be available (see flyer in the MPA packet). The \$50 recording fee is required. Bruce/Champagne: PASSED
