Mr. Venezio assigned mentors for new members.

Mr. Venezio opened the floor for nominations for District Secretary. Mrs. Laferriere nominated Mark Bailey. Mr. Chambers seconded. The motion was passed.

Item 3: Reading of Previous Minutes

There were no objections or changes to the minutes. They stand as distributed.

Item 4: Treasurer's Report

The balance in the checkbook as of August 17, 2002 stands at \$131.65. Mr. Venezio also reported that there is no other money coming from FMEA. Mr. Venezio stated that the proposed budget from this year is over \$22,000.

Item 5: Communications/Distribution of Packets

Mr. Venezio passed out the packets of material containing: the agenda, an FMEA survey, the calendar of district events, information about All-State auditions, All-State Participation Contract, List of Adjudicators for this year's MPAs and the FBA water fund-raiser information. Mr. Venezio said that all of the registration forms are available at www.flmusiced.org/fba.

Item 6: Unfinished Business

Mr. Venezio reported that the Executive Board and the membership has passed the Superior Award to be given to bands that receive an overall superior rating at state but do not qualify for the Otto J. Kraushaar Award.

<u>High School MPA Site</u>: Mr. Venezio reported that according to Mr. Jack Hart, East Ridge High School is ready for High School MPA. Mr. Lowery motioned that East Ridge High School be the site for High School MPA. Mr. Yopp seconded. Motion passed.

Item 7: Committee Reports

<u>District Honors Band:</u> Mr. Venezio appointed Mr. Doug Yopp as the coordinator for the District Honors Band. Mr. Yopp requests help. The auditions will be at Clermont Middle School. The dates are to be announced and he will be sending out information. The procedures are in last year's minutes online at www.flmusiced.org/fba. Mr. Vance has stated that West Port High School is not available January 23, 24, 25 to host the Honors Band.

Item 8: New Business

Mr. Perry from FSMA gave a presentation about the academic performance contract, student assessment, music advocacy, mentoring, registering for the convention online, and gave websites which have important information. These are: www.flca.net and <a href="www

Classification forms are due October 15th.

All-State Auditions will be held at Tavares Middle School September 14th beginning at 9:00 A.M. Thom Buchanan from EMR Records will be recording the auditions.

Mr. Venezio requests help for monitoring. Mr. Yopp stated that if you have students auditioning you must be there. Mr. Coney reminded directors to give the students the identical selection that they are supposed to play. He recommended that directors put the page numbers on the board.

Mr. Venezio stated that application forms with the fees (\$10 for the audition and \$5 for the recording) are due to him by August 30th so that he can set up an audition schedule that will be e-mailed to you. Mr. Venezio reminded directors to screen students carefully and hold a mock audition.

Small Schools Honors band Fees are \$15 per school. Applications are available on the website.

Mr. Venezio stated that when you nominate students for All-State Bands or if they audition you must have a completed All-State Participant's Contract with each and every student. So when they are accepted the person in charge will have it. The contracts are available on the website under conference and a copy was included in the director's packets.

Mr. Fielder from Leesburg High School will host Marching MPA. Mr. Fielder explained that everything is running smoothly and will be ready to go and to be looking in the mail for information.

Mr. Yopp, who will serve as announcer for the Marching MPA, asked that the announcement sheets be turned in early. When you get there please send someone to the press box or bring it yourself.

Mr. Venezio stated that the middle school directors will be needed for the Marching MPA. Mr. Venezio will get with Mr. Fielder and create a schedule for you.

Mr. Yopp requests that Mr. Fielder have change for the MPA.

Walter's Photography has offered a contract to take photos at Marching MPA with a donation of 15% of the profits with a minimum of \$700. They have included provisions for a multi-year agreement. For two years they would offer \$200 bonus and if three years they would offer \$300 bonus. Mr. Venezio opened the floor for discussion. Mrs. Laferriere motion to accept the Walters Photography contract for three years and Mr. Yopp seconded. Motion passed for a three-year photo contract.

Mr. Buchanan from EMR records will be recording the Marching MPA. He will bulk mail out Marching MPA compilation CDs within 60 days and is able to work with directors individually.

Item 9: District MPA Dates and Sites

Mr. Vance stated that West Port High School is available for Middle School Concert MPA. It is moved by Mrs. Laferriere to hold Middle School Concert MPA at West Port High School. It was seconded by Mr. Eason. Motion passed.

The District marching MPA date and site is November 9th at Leesburg High School. The District Jazz MPA is February 13, 2003 at Lake-Sumter Community College and will be hosted by Tavares High School. The District Solo & Ensemble MPA is February 14-15, 2003 at South Sumter High School. The Middle School MPA Date is February 28-March 1, 2003 at West Port High School.

Item 10: District MPA Adjudicators

Mr. Venezio included a list of MPA Adjudicators in the director's packets. Mr. Venezio informed everyone that all adjudicators are contracted.

Item 11: Nominations for Adjudicators List

District 19 has none at this time.

Item 14: Other

Mr. Bishop from TipTops talked about his advertisement on the website.

Mr. Coney stated that he is looking for a recording of Paul Creston's *Rhapsody*, a Grade VII. If anyone has a recording he appreciate if you would let him know.

Mr. Braddon says he will be servicing Marion and Citrus Counties as the Bringe Music representative replacing Bob Thompson who recently retired.
