- 2. Comments/Concerns/Suggestions: Big thanks to Skip Perry and the students and parents of Piedmont Lakes for their usual fantastic job with hosting!
 - a) <u>Concern</u>: (Berry) Use of portable with no air conditioning for student audition. Also expressed concern over actual recording being done by non-FBA members/directors. C. Sego stated that tapes were checked for proper recording throughout, and that recordings seemed to be consistent.
- b. Marching MPA
 - 1. Adjudicator Evaluation Forms please complete form found in packets, or on website, if any concerns or comments regarding judges and send to B. Sego.
 - 2. Parking overall, better this year. Potential need for crossing guard?
 - 3. Magic/DCI Wanted to have the Orlando Magic Drum Corps perform at MMPA as exhibition group; however, Hendon suggested that they should not due to the fact that DCI is a competitive organization.
 - a) <u>Discussion</u>: Berry understood that selling items on our site was the real issue; also, competition should not be imposed on FBA since Magic is competitive. Wilson district should have control over some issues and this should not have been a board issue. Flanagan miscommunication, was originally told it would be no problem for Magic to perform. Thomas they should have performed; it would have been good for the kids. Mendez issue of money/selling/advertising could get out of control.
 - 4. MS National Anthem Thanks to Jodi and Keith for a job well done! What to do for Ron Blocker? Parks copy of video recording and simple "thank you" letter from District, also a program and picture. Apologies about water mix-up and not handing out all food that was available to middle school students. Thanks to Timber Creek officers for helping with distribution. Middle school directors should have costs of busses available to B. Sego as this expense may be covered in the future.
 - 5. My ideas for next year: B. Sego stated that the board informed her that asking middle school directors to participate in assisting with marching performance assessment, or be assessed different amounts, was allowed. This will not be the policy next year. B. Sego also suggested that she would like to begin asking various businesses and companies for donations now. This may increase their willingness to include us in their budgets within their fiscal year. Also, if assessments can be cut in ½ through donations, additional monies could be given in the form of scholarships to senior(s) pursuing a degree in music. Two other thoughts: getting service groups to help with ticket taking, etc. or offering the job(s) to a particular group/school as a fundraiser. Finally, the Citrus Bowl itself is an incredible resource for us and helps with advocacy because it gives us the freedom to make this a "big deal."
 - 6. Comments / Concerns / Suggestions: Wilson legality of raising money by FBA, Inc. cannot be distributed to different groups or people. Sellers too many "ifs" yet. Berry judges expressed concern over hearing and seeing in the Citrus Bowl. Laniewski rope off area in second
- c. FMEA Clinic Conference
 - 1. \$5 more on site same for pre-registration
 - 2. Cancel rooms on time! penalty if canceled after November

- 3. Pre-conference is literacy if principal gives you a hard time about attending without students, you can list the conference on your PDP and may stand a better chance of getting support.
- 4. Ticket procedures are the same.
- d. Mentoring program concerns? none

Item 8: Committee Reports

We have no committees at this time; however, consider an adjudication committee and treasurer to alleviate work for the next chair.

Item 9: New Business

a. MOTION 1: To disband the current policy of a higher assessment for middle school directors who do not help with marching MPA.

Rationale:

- a) The current policy was never discussed or voted on by the district 8 membership.
- b) In other districts where this policy has been adopted, this policy was discussed by committee (in some cases) and by the district membership before a vote.
- c) This policy in no way helps to raise the marching MPA gate receipts. Therefore it does not reduce the per-entry assessment for MPAs. Sellers / Berry PASSED

Discussion: Lots of work on middle school director's part

- b. <u>MOTION 2</u>: To adapt a policy that no alternative assessments be implemented by district 8 without going first through a committee selected by the district membership, discussed by the district membership at a regular meeting, and voted on by the district membership at a regular meeting. Rationale:
 - a) Every effort must be made to be sure the handling of taxpayers' money is done properly and lawfully. In addition, all district members must be given the opportunity to voice their concerns/opinions concerning the handling of money. Sellers / Rogier PASSED
- c. MOTION 3: To adapt the following policy with regard to venues for any FBA event:

Schools that participate in any FBA event held at a venue that requires a rental fee or any other costs beyond what is customary to cover and event held at a conventional facility (such as a public school), will share these above mentioned costs equally among the participating schools.

For example, if the middle school directors agree to hold their Concert Band Music Performance Assessment at The Bob Carr Performing Arts Center in downtown Orlando, the participating schools will share the cost of the hall rental and any other costs beyond what is customary to cover such an event held at a conventional facility (public school).

Rationale:

- a) As costs continue to rise and budget cuts are made, we must make every effort to reduce/minimize our per-entry assessment for MPAs. Because our income consists primarily of per-entry assessments, all unnecessary expenses must be eliminated.
- b) This motion provides for an exception for those who wish to upgrade to a venue requiring a rental fee or extra costs, without placing the additional financial burden on the schools that do not benefit from the upgrade(s).

 Sellers / Frankenstein OUT OF ORDER

Discussion:

- a) Parks can we have different assessments for different festivals?
- b) Laniewski concerned about seating, at Citrus Bowl all school's can sit on one side and see bands from the front.
- c) Mark Ellis concerned about middle school vendetta
- d) Frankenstein just like high schools want Citrus Bowl, middle schools want good hall for concert MPA.

- e) Janeiro concerned over stress in unity of association
- f) Berry assessment is killing middle school budgets
- g) Bujnicki wants what's best for kids
- h) Wilson assessments are figured by adding all expenses and then dividing that amount by the expected number of participants. Also suggested lowering school's assessments by doing fewer events.

<u>Vote</u>: A vote was taken by secret ballot on this motion. The result was 24 no, 18 yes.
